Chandrababu Naidu, quoted Former US President Franklin Roosevelt, who defined a true democracy as having four freedoms: freedom of expression, freedom from fear, freedom of faith, and freedom from want.

But, and do get this straight, all these four freedoms are bettered and are possible only if we have freedom from the past. ### Injury-recovered players may return for Asia Cup: Dravid

Chennai, Aug 15: Team India Coach Rahul Dravid hinted at a few injured players making a comeback into the side for the Asia Cup.

"We have a few players coming back from injuries - to name a few, we have to give them opportunities to play in Asia Cup," he told reporters at the NCA.

Dravid's comments come as the wake of K.L. Rahul and Shreyas Iyer undergoing fitness training at the National Cricket Academy in Bangalore.

Shreyas Iyer suffered a back injury during the Test series against Australia earlier this year whereas Rahul sustained a thigh injury during the IPL 2023.

Both are recuperating after undergoing surgery at the NCA, but there has not been any confirmation on their return into the national team. However, they might be a part of the preparation camp for Asia Cup at NCA, beginning August 23.
