### Decomposed body of woman found inside gunny bag near crematorium

#### **EXPRESS NEWS SERVICE** PUNE, AUGUST 13

THE DECOMPOSED body of an unidentified woman, with her hands and legs tied, was found inside a gunny bag in Indrayani riverbed near Alandi town in Pune district on Thursday morning.

A First Information Report in the case has been registered at Alandi police station. Officials said the body was found in Indrayani riverbed in Chimbli village next to a crematorium. Around 10 am on Thursday some women who were collecting garbage stumbled upon the white gunny bag and found the decomposed body inside it.

They informed the deputy sarpanch of the village, who in turn called the local police station. On Thursday evening, a case was registered under Indian Penal Code sections 302 (murder) and 201 (destruction of evidence).

उपवनसंरक्षक शिवकुमार आणि अपर प्रधान मुख्य वनसंरक्षक श्रीनिवास रेड्डी दोघांनाही अटक झाली. दरम्यान, रेड्डी यांनी जामिनासाठी व आपल्याविरुद्ध गुन्हा रद्द करण्यासाठी उच्च न्यायालयात धाव घेतली. या याचिकेवर न्या. अतुल चांदूरकर आणि न्या. न्यायालयाच्या नागपूर खंडपीठाने गोविंद सानप यांच्यासमक्ष सुनावणी झाली. सर्व पक्षांची बाजू ऐकल्यानंतर न्यायालय म्हणाले. पोलिसांनी सादर केलेले पुरावे आणि साक्षीदारांच्या जबाबातून रेड्डी यांनी दीपालीला आत्महत्येस प्रवृत्त केल्याचे स्पष्ट होत नाही. त्यामुळे त्यांच्याविरुद्धचा गुन्हा रद्द करण्यात यावा. रेड्डींतर्फे वरिष्ठ अधिवक्ता सुनील मनोहर, फिर्यादी राजेश मोहिते तर्फे ॲड. अभय सांभरे आणि राज्य सरकारच्यावतीने ॲड. संगीता जाचक यांनी बाजू मांडली.

## उच्च न्यायालयाचे निरीक्षण...

आत्महत्येला प्रवृत्त करण्यासाठी प्रत्यक्ष किंवा अप्रत्यक्ष जबाबदार असल्याचे पुरावे असणे आवश्यक आहे. प्रत्यक्ष सहभाग नसल्यास दुसऱ्याच्या कटात सामील असायला हवे व तसे पुरावेही हवे. दीपालीने लिहिलेल्या तिन्ही चिड्ठ्यांमधून शिवकुमार तिच्या आत्महत्येस जबाबदार असल्याचे दिसून येते. पण, एखाद्याविरुद्ध आपल्याला अपेक्षित असलेली सकारात्मक कारवाई केली नाही म्हणून कुणी अधिकारी आत्महत्येस प्रवृत्त करण्यासाठी जबाबदार धरला जाऊ शकत नाही. शिवाय दीपालीने रेड्डीना उद्देशून लिहिलेल्या चिठ्ठीत त्यांनी तिला वेळोवेळी सहकार्य केल्याचे नमूढ आहे. ऑक्टोबर २०२० मध्ये केलेल्या तक्रारीवर कारवाई केली नाही व शिवकुमारची पाठराखण केली, असा आरोप आहे. पण, ही घटना आत्महत्या घडण्याच्या पाच महिन्यांपूर्वीची आहे. शिवाय दीपालीला केलेल्या संदेशात 'तुम उसके खिलाफ लिखित तक्रार करना चाहती हो तो ठीक है, पर संभलके' या वाक्यासाठी भाढंविच्या १०७ कलमान्वये कारवाई होऊ शकते. पोलिसांनी साढ्र केलेले पुरावे आरोपीने तिला आत्महत्येस प्रवृत्त करण्याच्या कृत्यासाठी खटला चालवण्याकरिता पुरेसे नाहीत, असे निरीक्षण उच्च न्यायालयाने आपल्या आदेशात नोंदवले आहे.


