To the Board of Directors of Regis Industries Limited (Formerly known as Bhartia Bachat Limited)

1. We have reviewed the accompanying Statement of unaudited consolidated financial results of **Regis Industries Limited (Formerly known as Bhartia Bachat Limited)** for the quarter ended 30 June 2022 ("the Statement"), being submitted pursuant to the requirements of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('Listing Regulations').
