1. <u>Date, time and venue of the 34th Annual General Meeting (Meeting):</u>

The 34th Annual General Meeting of the Company was held on Friday, 23rd September, 2022 at Palm Green Hotel and Resort, Main GT Karnal Road, Bakoli, New Delhi- 110036.

The meeting commenced at 11.00 A.M (IST) and concluded at 12.30 P.M.

2. <u>Proceedings in Brief:</u>

Mr. Vijay Bansal, Chairman and Managing Director, occupied the Chair as the Chairman of the Annual General Meeting. Mr. Vijay Bansal, the Chairman welcomed the members to the 34th Annual General Meeting.

Ms. Poonam Chahal, Company Secretary & Compliance Officer of the Company introduced the persons sitting on the dias. The requisite quorum was present and called the meeting to be in order. All the Director of the Company attended the meeting. The Chairman delivered his speech.

Pursuant to the provisions of the Companies Act 2013, and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the `Listing Regulations'), the company had provided the facility to the members to cast their vote electronically on all resolutions set forth in the Notice. The shareholders who were present at the AGM and had not cast their votes electronically were provided an opportunity to cast their votes at the end of the meeting. It was further informed that there would be no voting by show of hands.

With the consent of the members, the Notice of the 34th AGM and Auditor's Report was taken as read.

Company Secretary explained the Process for voting through ballot paper in the AGM.



Company Secretary informed the members that M/s. Sanjay Grover & Associates, Company Secretaries were appointed as scrutinizers for the purpose of scrutinizing e voting facility and ballot voting process.

Company Secretary further informed that Auditor's Report, Financial Statements and Secretarial Audit Report for the financial year ended on March 31, 2022 do not contain any qualification, reservation, adverse remarks or disclaimer and therefore, the same were taken as read.

It was announced by the Company Secretary that Notice of 34th Annual General Meeting dated August 09th, 2022 was sent to the members physically for approval of the members through e-voting or ballot paper at the AGM which contains the following resolution:-

Ordinary Businesses:

- 1. To receive, consider and adopt the Audited Financial Statements of the Company for the Financial Year ended on March 31, 2022 together with the report of the Board of Directors and the Auditors thereon.
- 2. To Confirm payment of interim dividend of Rs. 1/- (rupee one only) per share i.e @ 10% on equity share of face value of Rs. 10/- (rupees ten only) each, fully paid up, for the financial year ended on 31 March 2022 and declaration of Final Dividend on equity shares of Rs. 1.50/-(rupees one and fifty paise only) i.e. @ 15% of face value of rs. 10/- (rupees ten only) each , fully paid up, for the Financial Year ended on 31 march 2022
- **3.** To appoint a Director in place of Mr. Basant Goyal (DIN: 07659491), who retires by rotation and being eligible, offers himself for re-appointment.
- 4. To appoint M/s Suresh and Associates., Chartered Accountants as the Statutory Auditor of the Company
