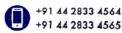

Independent Auditor's Review Report on the Unaudited Standalone Financial Results of **KOTHARI INDUSTRIAL CORPORATION LIMITED** (the Company) pursuant to the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, as amended, for quarter ended 30th June 2024

TO THE BOARD OF DIRECTORS KOTHARI INDUSTRIAL CORPORATION LIMITED

- 1. We have reviewed the accompanying Statement of Unaudited Standalone Financial Results of KOTHARI INDUSTRIAL CORPORATION LIMITED ("The Company") for the quarter ended June 30, 2024 ("the Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended including relevant Circular issued by SEBI from time to time.
- 2. This statement, which is the responsibility of the Company's Management and approved by the Board of Directors has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34, 'Interim Financial Reporting' (Ind AS 34) prescribed under Section 133 of the Companies Act 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to issue a report on these financial results based on our review.
- 3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 "Review of Interim Financial Information performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review of interim financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.
- 4. Based on our review conducted and procedures as stated above, nothing has come to our attention that causes us to believe that the accompanying Statements of Standalone Unaudited Financial Results prepared in accordance with recognition and measurement principles laid down with aforesaid Accounting Standard and other accounting principles generally accepted in India has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, including the manner in which it is to be disclosed, or that it contains any material misstatement except for the matters included in the paragraph of conclusions as below.

- As reported by us in our audit report for the year ended 31st March 2024, the Company has sold its land and plant and machinery located in its factory in Ennore to Coromandel International Limited for Rs 48,95,00,000 and Rs 1,33,00,000 respectively for which the assessment of market value for stamp duty purposes was pending. Subject to this, the Company had computed capital gains on the sale consideration as per the sale deed. The final outcome of the order is still pending in the current period.
- 2) Confirmation of balances in respect of trade receivables, trade payables, vendor advances, advances from customers and other advances have not been provided for our verification and record for all parties. In the absence of such external confirmations, we are unable to ascertain any consequential effect of the above to the profit and loss for the period.
- 3) Interest on Managing Director's loan has not been provided for in the books of accounts for the quarter ended 30th June 2024. In the absence of sufficient documents for our review, the impact of the same in the profit and loss statement could not be ascertained.
- 4) Out of the total revenue of the Company Rs 13,62,81,667 sufficient appropriate audit evidence by way of agreements/work orders etc was not provided for Rs 64,39,108.41. Hence, we are unable to substantiate the correctness of these revenues.
- 5) The Company has receivable in GST account as per books of Rs 27,40,751 which has not been reconciled with the GST portal which shows Rs 58,17,265. Further, there is a debit balance in GST payable account in the books amounting to Rs 32,45,434 (net) as against a liability of Rs 15,92,744 in the GST return filed for the month of June 2024. We are unable to verify the same in the absence of reconciliation by the Company.

 Due to such statutory non-compliance, we are unable to comment on the actual recoverability and payment of the dues against such balances.
- 6) TDS defaults appearing in TRACES is Rs 21,32,758.68 (out of which Rs 15,16,131 is for the period prior to FY 2020-21) is still outstanding as on the date of this report.
- 7) Remittance of TDS deducted u/s 194J- Rs 3,83,413, 194C- Rs 1,79,484, 194IB- Rs 6,89,847, 192B- Rs 31,01,632, 194H- Rs 32,148, 194A-Rs 9,45,948 could not be verified with challans.
- 8) Intangible assets of Rs 2,21,27,465 has been capitalized during the current quarter. However, we are unable to verify the correctness of this capitalization in the absence of proper documentation and workings.
- 9) The proceedings initiated by the Collector of Nilgiris for repossession of certain plots of land in Coonoor earmarked for public use has been challenged by the company on a Write Petition filed before Madras High Court and the matter is pending adjudication. Decision, if any, by the Madras High Court which does not go in favor of the Company, could give rise to a liability and consequential loss, which could not be ascertained at the balance sheet date.

10) Maintenance charges collected by the Company reportedly on behalf of Kothari Sugar Limited from various parties is Rs 14,31,420. However, the Company has been billed only Rs 3,85,160 for the period by Kothari Sugars Limited. No reconciliation has been provided to us for this difference. Further, no documentary evidence was made available to us for these charges.

We did not review the interim financial results and other financial information of the above subsidiary whose interim financial results reflect total assets of Rs 9.17 lakhs as at 30th June 2024, total revenues of Rs Nil, total net loss after tax of Rs 0.03 lakhs and total comprehensive income of Rs (0.03) lakhs for the quarter ended 30th June 2024 included in the consolidated unaudited financial results. This interim financial result has been reviewed by other auditor, whose report has not been furnished to us by the management and our conclusion on the statement in so far as it relates to the amount and disclosures is based solely on representation by the Management. Our conclusion on the statement is not modified in respect of the above matter.

on 14th August 2024.

3 The Company is engaged in trading of Fertilizer, Leather, Hotel, Drone.

Amended-The Company has generated profits during the current Quarter and has brought forward losses from previous years. The management has a clear business plan for expansion with plans for additional financing. The Company believes it has adequate financial resources to continue operations for the foreseeable future.

4 Accordingly, the financial statements have been prepared on a going concern basis.

During the financial year 2023-24, the Company sold its land and plant and machinery located at its Ennore factory to Coromandel International Limited for Rs. 48,95,00,000 and Rs. 1,33,00,000, respectively. The Company intends to file a writ petition under Section 50C of the Income Tax Act, 1961, challenging the market value assessed by the Sub-Registrar's Office (SRO). Meanwhite, the Company has calculated capital gains based on the actual sale consideration received.

Depending on the outcome of the competent authority's order on the writ petition, the provision for income tax may need to be revised.

The proceedings initiated by the Collector of Nilgiris for the repossession of certain plots of land in Coonoor, earmarked for public use, have been challenged by the

6 Company through a writ petition filed before the Madras High Court. The matter is currently pending adjudication.

The figures of the previous periods have been regrouped and reclassified wherever necessary.
