अंबरनाथच्या कचराभूमीचा प्रश्न अखेर निकाली

अंबरनाथ : अंबरनाथ पूर्वेतील मोरीवली पाड्याशेजारी गेल्या अनेक वर्षांपासून सुरू असलेली बेकायदा कचराभूमी बुधवारपासून बंद केली जाणार आहे. उच्च न्यायालयाने एक महिन्याची मुदत दिल्यानंतर अंबरनाथ नगरपालिकेने चिखलेली येथे नव्या कचराभूमीसाठी परवानगी मिळवली आहे. नुकतीच ठाणे जिल्हाच्या पालकमंत्र्यांनी चिखलेलीतील आरक्षित भूखंडावर कचरा टाकण्यास परवानगी दिल्यानंतर बुधवारपासून या कचराभूमीवर कचरा टाकला जाणार आहे. अंबरनाथ नगरपालिकेने गेल्या काही वर्षांपासून मोरीवली पाडा या भागात कर्जत-काटेई महामार्ग आणि कल्याण-बदलापूर राज्य मार्गाच्या जोडमार्गावर बेकायदा पद्धतीने कचरा टाकण्यास सुरुवात केली होती. अंबरनाथ शहराचा विस्तारणारा भाग



असल्याने या ठिकाणी मोठ्या प्रमाणावर रहिवासी संकुले उभी राहिली आहेत. बांधकाम व्यावसायिकांकडून ही कचराभूमी काही दिवसात हटवली जाईल, असे आश्वासन मिळाल्याने नागरिकांनी या भागात घरे विकत घेतली. मात्र कचराभूमीचा प्रश्न रखडल्याने नागरिकांना कायम दुर्गंधीचा त्रास सहन करावा लागत होता. या प्रकरणी विविध राजकीय पक्ष, सामाजिक संघटना, पर्यावरणप्रेमी आणि नागरिकांनी शेकडो आंदोलने केली. क्षमता संपल्यानंतरही पालिका प्रशासन या ठिकाणी कचरा टाकत होते. सातत्याने आग लागण्याच्या घटनांमुळे शहराच्या मोठ्या भागात धुराचे साम्राज्य

पसरत होते. याची दखल राष्ट्रीय हरित लवाद, उच्च न्यायालयानेही घेतली. या कचराभूमीच्या समोरच अंबरनाथ शहरातील कनिष्ठ न्यायालय सुरू होण्याच्या प्रतीक्षेत आहे. त्यावरून गेल्या महिन्यात उच्च न्यायालयाच्या न्यायाधीशांनी अंबरनाथ नगरपालिकेच्या कारभारावर नाराजी व्यक्त केली होती. तसेच अंबरनाथ नगरपालिकेला एक महिन्याचा अवधी दिला होता. त्यानंतर अंबरनाथ नगरपालिकेने कचराभूमीच्या नव्या जागेसाठी हालचाली सुरू केल्या. अखेर अंबरनाथच्या चिखलेली भागातील सर्वेक्षण क्रमांक ३३२ या कचराभूमीसाठी आरक्षित जागेची निश्चिती झाली. पालकमंत्री एकनाथ शिंदे यांनी नुकत्याच झालेल्या दूरचित्र संवाद बैठकीत चिखलेली येथील जागेचा वापर करण्यासाठी परवानगी दिली.

डॉंबिवली रेल्वे स्थानकात १४३४ तर कोपर रेल्वे स्थानकात १५० नागरिकांच्या लसीकरण प्रमाणपत्राची पडताळणी



डॉंबिवली : शासनाच्या मार्गदर्शक सूचनांनुसार कोविड लसीकरणचे दोन डोस पूर्ण होऊन १४ दिवस पूर्ण झालेल्या नागरिकांना रेल्वे प्रवासाची अनुमती देण्यात आली आहे. सदर नागरिकांना रेल्वे पास मिळणे सुकर व्हावे याकरिता त्यांचे कोविड लसीकरण प्रमाणपत्राची पडताळणी करण्याकरिता महापालिका कार्यक्षेत्रात कल्याण, डॉंबिवली, कोपर, टिटावळ, आंबीवली, शहाड, ठाकुर्ली या रेल्वे स्थानकांवर महापालिकेने

सकाळी ७ ते दुपारी ३ व दुपारी ३ ते रात्री ११ या दोन सत्रात महापालिका कर्मचाऱ्यांचे मदत कक्ष उभारण्यात आले आहेत. बुधवारी सकाळी ७ वाजता महापालिका क्षेत्रातील सर्व रेल्वे स्थानकांवर महापालिकेचे कर्मचारी हजर होते. या पहिल्या सत्रात कल्याण पूर्वी रेल्वे स्थानक येथे १६८, कल्याण पश्चिम रेल्वे स्थानक येथे २८४, डॉंबिवली पूर्वी रेल्वे स्थानक येथे ८२७, डॉंबिवली पश्चिम रेल्वे स्थानक येथे ६०७, ठाकुर्ली रेल्वे स्थानकावर १९९, शहाड रेल्वे

स्थानकावर १५, आंबिवली रेल्वे स्थानकावर ५१, कोपर रेल्वे स्थानकावर १५०, टिटावळा रेल्वे स्थानकावर २०४ अशा एकुल २५०६ नागरिकांच्या प्रमाणपत्राची पडताळणी करण्यात आली. दुपारच्या दुस-या सत्रातही नागरिकांच्या लसीकरण प्रमाणपत्राची पडताळणी केली जात आहे. नागरिकांनी सदर पडताळणीसाठी गर्दी न करता प्रशासनास सहकार्य करावे, असे आवाहन महापालिकेमार्फत करण्यात येत आहे.
