अंबरनाथच्या कचराभूमीचा प्रश्न अखेर निकाली

अंबरनाथ : अंबरनाथ पूर्वेतील मोरीवली पाड्याशेजारी गेल्या अनेक वर्षांपासून सुरू असलेली बेकायदा कचराभूमी बुधवारपासून बंद केली जाणार आहे. उच्च न्यायालयाने एक महिन्याची मुदत दिल्यानंतर अंबरनाथ नगरपालिकने चिखलोली येथे नव्या कचराभूमीसाठी परवानगी मिळवली आहे. नुकतीच ठाणे जिल्ह्याच्या पालकमंत्र्यांनी चिखलोलीतील आरक्षित भूखंडावर कचरा टाकण्यास परवानगी दिल्यानंतर बुधवारपासून कचराभूमीवर कचरा टाकला जाणार आहे. अंबरनाथ नगरपालिकेने गेल्या काही वर्षांपासून मोरीवली पाडा या भागात कर्जत-काटई महामार्ग आणि कल्याण-बदलापूर राज्य मार्गाच्या जोडमार्गावर बेकायदा पद्धतीने कचरा टाकण्यास सुरुवात केली होती. अंबरनाथ शहराचा विस्तारणारा भाग



असल्याने या ठिकाणी मोठ्या प्रमाणावर रहिवासी संकुले उभी राहिली आहेत. बांधकाम व्यावसायिकांकडून ही कचराभूमी काही दिवसात हटवली जाईल, असे आश्वासन मिळाल्याने नागरिकांनी या भागात घरे विकत घेतली. मात्र कचराभूमीचा प्रश्न रखडल्याने नागरिकांना कायम दुर्गंधीचा

त्रास सहन करावा लागत होता. या प्रकरणी विविध सामाजिक संघटना, पर्यावरणप्रेमी आणि नागरिकांनी शेकडो आंदोलने केली. क्षमता संपल्यानंतरही पालिका प्रशासन या ठिकाणी कचरा टाकत होते. सातत्याने आग लागण्याच्या घटनांमुळे शहराच्या मोठ्या भागात धुराचे साम्राज्य
