Mr. Kutabudeen Kuraishi, Company Secretary and Compliance Officer welcomed all Members, Directors and other invitees to the 23rd Annual General Meeting (AGM) of the members of City Pulse Multiplex Limited ('the Company') held on Friday, 29th September, 2023 at 11:00 a.m. IST through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM").
