AGRA: Three people, including two minors, were killed while their tractor-trolley fell into a canal here on Friday, police said.

The injured are under treatment at a hospital in Agra, said Somendra Meena, deputy commissioner of police (East).

The people were returning from a ceremony when the accident occurred on the Saiyan-Iradatnagar road. The children died on the

spot while the man succumbed to injuries at a hospital, police said.

"The reason behind the accident will be known after a probe.

The driver was not in a condition to share many details," Meena said.

EXPLOITED FOR 6 MONTHS, NURSE LODGES FIR, 2 ARRESTED

MEERUT: A nurse of the NMC Medical College, under Kharkhanda police station of Meerut district, was sexually exploited for six months before she gathered the courage to approach the police and lodge a complaint on Thursday.

Police have arrested both the accused and the nurse has been sent for medical examination. Rupal Roy Choudhary, circle officer, Kithore area, confirmed that a case has been registered against the ward boys on the complaint of the victim.

In her complaint, the nurse said that almost six months ago, the ward boys called her to the top floor of the college for some work. There, they raped her and took objectionable photographs and threatened her to make the photographs viral if she dared open her mouth.

Roy said that taking advantage of her fear they also took her to a hotel and assaulted her there.

Lure of lucre makes docs ditch government jobs

39% of 225 candidates selected didn't join state medical colleges

LUCKNOW: In a recent selection of candidates for the post of assistant professor in different state-run medical colleges, 225 were selected, of which 137 joined, and 88 didn't. That is 39% of the total selected did not join duties.

The selection list was announced on May 31 and the selected candidates were asked to join immediately.

Better pay in the private sector and location of work is making candidates ditch government medical institutions and join the private sector instead, doctors said.

These candidates had been selected for 11 different medical institutes. Highest number of assistant professors who did not join service are 15 in Ambedkar-nagar, followed by Azamgarh 14, Kannauj 13, Badaun 12, Saharanpur 11, Jalaun 8, Banda 4, Kanpur 3, Meerut 2 and Gorakhpur 4.

Following the cancellation of a candidature, again, a fresh advertisement for appointment on these 88 posts of assistant teachers, and more (if vacant), will be issued and entire process for appointment will be conducted by the UPPSC. Such appointments take over two months to complete from the date when the advertisement is issued.

Not just in medication education but in the health department too, a similar situation had come up. In all, 1,057 doctors were selected after the interview and 415 were asked to join regular service in provincial medical services but just over 200 joined.

"If these selected candidates do not join by the last date given in the circular, a proposal to cancel their candidature will be sent to the state administration," said Kinjal Singh, director-general, medical education (DGME). Commenting on the issue, Dr

Amit Singh, general secretary, Provincial Medical Services Association (PMSA), a body of government doctors said, "To fulfil the protocol of the National Medical Commission (NMC) annual teaching smoothly, specialist doctors from the PMS - since these specialists are already in state government service - can be deployed as faculty members, based upon their experience and willingness to join teaching posts."

At present, the medical education department is working to start one medical college in every district. At present 63 districts have medical colleges and a majority of them were started between 2017 and 2022.

Avoid sharing pics of animal sacrifices online: Islamic Centre of India

LUCKNOW: A detailed advisory has been issued on Thursday by the Lucknow-based Islamic Centre of India for Eid-ul-Azha (Bakrid), advising Muslims against uploading pictures of animal sacrifice on social media and to respect religious sentiments of other communities too.

Bakrid would be celebrated on June 29 across the country and in its advisory the chairman of the Islamic Centre, Maulana Khalid Rashid Farangi Mahali, has also said the community must ensure that only those animals are sacrificed on which there is no legal restriction. "Legal provisions should be kept in mind while performing sacrifice. Cleanliness must be

ensured and photos or videos of sacrifice should not be made or shared on social media," said the cleric, who is also the imam of Lucknow Eidgah.

"Sacrifice should not be done in any open space or by roadside and public places. No animal waste should be thrown on roads or public places after sacrifice but kept inside municipal dustbins. We must respect the religious sentiments of others while performing sacrifice. Those performing sacrifice should ensure that blood of sacrificial animals isn't poured out on the drains," the cleric said in his advisory. "The distribution of animal meat should be done after packing it properly and one third of the sacrifice meat must be distributed among poor and needy," the cleric said.

लापता पनडुब्बी 'टाइटन' विस्फोट के कारण नष्ट हुई

पानी में उतरते ही विस्फोट

स्कूल ऑफ इलेक्ट्रिकल एंड मैकेनिकल इंजीनियरिंग, यूनिवर्सिटी ऑफ एडीलेड के एसोसिएट प्रोफेसर एरिक फुसिल ने कहा, हम मान सकते हैं कि विस्फोट उसी दिन हुआ, जिस दिन पनडुब्बी पानी में उतरी थी। पानी में गहराई पर चलने वाली अधिकतर पनडुब्बियों में एक दाब पात्र होता है, जो एकल धातु सामग्री से बना होता है। आमतौर पर 300 मीटर से कम गहराई के लिए स्टील और अधिक गहराई के लिए टाइटेनियम का इस्तेमाल किया जाता है। टाइटेनियम या मोटे स्टील वाला दाब पात्र आमतौर पर गोलाकार होता है और यह 3,800 मीटर गहराई तक दबाव झेल सकता है। टाइटेनियम का दाब पात्र टाइटेनियम और मिश्रित कार्बन फाइबर के मेल से बना था।

एरिक ने बताया कि टाइटेनियम लचीला है और वायुमंडलीय दबाव में वापसी के बाद उसके अनुसार ढल जाता है। यह दबाव डालने वाले बलों के अनुकूल सिकुड़ भी सकता है और इन बलों के कम होने पर फिर से फेल जाता है। कार्बन-फाइबर अधिक कठोर होता है और इसमें ऐसा लचीलापन नहीं होता। दो अलग-अलग प्रौद्योगिकियों की सामग्रियों में अंतर के कारण कोई गड़बड़ हुई और पानी के नीचे दबाव के कारण विस्फोट हुआ होगा और इसमें सवार यात्रियों की 20 मिली सेकंड से भी कम समय में मौत हो गई होगी।

Lure of lucre makes docs ditch government jobs

39% of 225 candidates selected didn't join state medical colleges

LUCKNOW: In a recent selection of candidates for the post of assistant professor in different state-run medical colleges, 225 were selected, of which 137 joined, and 88 didn't. That is 39% of the total selected did not join duties.

The selection list was announced on May 31 and the selected candidates were asked to join immediately.

Better pay in the private sec-

tor and location of work is making candidates ditch government medical institutions and join the private sector instead, doctors said.

These candidates had been selected for 11 different medical institutes. Highest number of assistant professors who did not join service are 15 in Ambedkar-nagar, followed by Azamgarh 14, Kannauj 13, Badaun 12, Saharanpur 11, Jalaun 8, Banda 4, Kanpur 3, Meerut 2 and Gorakhpur 4.

Following the cancellation of a candidature, again, a fresh advertisement for appointment on these 88 posts of assistant teachers, and more (if vacant), will be issued and entire process for appointment will be con-

ducted by the UPPSC. Such appointments take over two months to complete from the date when the advertisement is issued.

Not just in medication education but in the health department too, a similar situation had come up. In all, 1,057 doctors were selected after the interview and 415 were asked to join regular service in provincial medical services but just over 200 joined.

"If these selected candidates do not join by the last date given in the circular, a proposal to cancel their candidature will be sent to the state administration," said Kinjal Singh, director-general, medical education (DGME). Commenting on the issue, Dr

Amit Singh, general secretary, Provincial Medical Services Association (PMSA), a body of government doctors said, "To fulfil the protocol of the National Medical Commission (NMC) annual teaching smoothly, specialist doctors from the PMS - since these specialists are already in state government service - can be deployed as faculty members, based upon their experience and willingness to join teaching posts."

At present, the medical education department is working to start one medical college in every district. At present 63 districts have medical colleges and a majority of them were started between 2017 and 2022.

SIT yet to submit report as extended deadline ends

LUCKNOW: The two-week extended deadline for the three-member Special Investigation Team (SIT) investigating the killing of gangster Sanjeev Maheshwari in a Lucknow court ended on Thursday.

The state government had on June 7 constituted the SIT headed by additional DGP (technical) Mohit Agarwal while Lucknow's joint commissioner of police (crime) Nilabja Choudhury and IG (Ayodhya range)

A SENIOR POLICE OFFICIAL SAID THE SIT HAD COMPLETED ITS INQUIRY, BUT WAS NOT SURE WHEN THE REPORT WILL BE SUBMITTED.

Praveen Kumar were its other members. The team was initially given one week till June 14 to submit its report, but the deadline was extended to two weeks.

A senior police official said the SIT had completed its inquiry, but was not sure when the report will be submitted. The

process of recording the statements of police personnel deployed to bring Jeeva from Lucknow district jail to the court and some other cops deployed to ensure security of the court had already been done.

He said the recreation of the crime scene in which the shoot-

out took place had also been done.

The SIT had visited the crime scene inside the SC/ST court at the old high court building, on Wednesday (June 7) night. Gangster Jeeva was shot dead allegedly by one Vijay Yadav alias Anand Yadav, 26, who entered the court in the guise of a lawyer.

Three other people, including two head constables and an 18-month-old girl, were injured in the shootout, and they all recovered from their injuries.

Avoid sharing pics of animal sacrifices online: Islamic Centre of India

LUCKNOW: A detailed advisory has been issued on Thursday by the Lucknow-based Islamic Centre of India for Eid-ul-Azha (Bakrid), advising Muslims against uploading pictures of animal sacrifice on social media and to respect religious sentiments of other communities too.

Bakrid would be celebrated on June 29 across the country and in its advisory the chairman of the Islamic Centre, Maulana Khalid Rashid Farangi Mahali, has also said the community must ensure that only those animals are sacrificed on which there is no legal restriction. "Legal provisions should be kept in mind while performing sacrifice. Cleanliness must be

ensured and photos or videos of sacrifice should not be made or shared on social media," said the cleric, who is also the imam of Lucknow Eidgah.

"Sacrifice should not be done in any open space or by roadside and public places. No animal waste should be thrown on roads or public places after sacrifice but kept inside municipal dustbins. We must respect the religious sentiments of others while performing sacrifice. Those performing sacrifice should ensure that blood of sacrificial animals isn't poured out on the drains," the cleric said in his advisory. "The distribution of animal meat should be done after packing it properly and one third of the sacrifice meat must be distributed among poor and needy," the cleric said.

विवरण में संशोधन नहीं कर पा रहे : विशेषज्ञों के अनुसार, नियोक्ताओं और कर्मचारियों को ईपीएफओ पोर्टल पर कर्मचारी के विवरण को अपडेट करने की अनुमति दी गई थी लेकिन ऐसा सुधार केवल ईपीएफओ के माध्यम से ही संभव है। इसमें दो महीने से अधिक समय लगता है और प्रक्रिया धीमी हो जाती है। ईपीएफओ के पोर्टल पर आवेदनकर्ता और नियोक्ता के विवरण को बदले बिना ऊंची पेंशन के लिए आवेदन दाखिल नहीं किया जा सकता है।



टिवटर पर शिकायतों का अंबार लगा

कई ईपीएफओ सदस्यों ने टिवटर पर उन मुद्दों को उठाया है, जिनका उन्हें ज्यादा पेंशन आवेदन जमा करते समय सामना करना पड़ रहा है। कई सदस्यों ने ट्वीट किया कि यूनिवर्सल अकाउंट नंबर (यूएन) और आधार कार्ड में सभी विवरण सही होने के बावजूद वे आवेदन जमा नहीं कर पा रहे हैं। बार-बार तकनीकी गड़बड़ी का संदेश वेबसाइट पर आ रहा है। उन्होंने इसका स्क्रीनशॉट भी संगठन को भेजा है।
