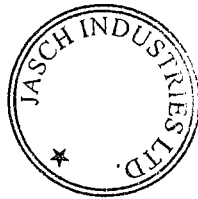

Members who have not provided their PAN to the Company/their DP so far are urged to provide the same within seven days hereof as, in some cases, it will be necessary to generate their password for logging in for e-voting/attending AGM.

Result will be declared within 48 hours of conclusion of AGM and will be posted at the above website of the Company under the link "Notices".
