I, Shikha Naredi, Practicing Company Secretary, have been appointed as the Scrutinizer by the Board of Directors of J. A. Finance Limited ("the Company") for the purpose of remote-e voting and voting by poll taken on the below mentioned resolutions at the 30th Annual General Meeting of the Shareholders of the Company held on Thursday, 21st Day of September 2023 at 12:45 P.M. at 1st Floor, Punwani Chambers, 7B, Kiran Shankar Roy Road, Kolkata- 700001 submit my report as under:

- The company had appointed Central Depository Services (India) Limited ("CDSL") as the Agency for providing e-voting facility to the shareholders for the 30th AGM, held on 21st Day of September 2023.
- 2. The remote e-voting period remained begins on 18th September 2023 at 09:00 a.m. and ends on 20th September 2023 till 5:00 p.m.
- 3. The shareholders holding shares as on the "cut off" date i.e. Thursday, 14th September 2023 were entitled to vote on the proposed resolutions (Items No. 1 to 2 as set out in the Notice of the 30th Annual General Meeting of the Company).
- 4. On 21^{tst} Day of September at the 30th Annual General Meeting, ballot papers were distributed to the shareholders present in persons to enable them to vote who could not do remote e-voting.
- 5. After the time fixed for closing of poll by the Chairman, one ballot box kept for polling was locked in my presence.
- 6. The locked ballot box was subsequently opened in my presence and poll papers were scrutinized.
- 7. Due to technical glitches, I am unable to enter ballot voting in CDSL scrutinizer portal, However manual vote have been considered while preparing this report.
