देश का निर्यात अक्तूबर में 5.4 फीसद गिरकर 24.82 अरब डॉलर पर आ गया। मंगलवार को जारी सरकारी आंकड़ों के मुताबिक इसकी वजह पेट्रोलियम उत्पादों. रत्न व आभषणों. इंजीनियरिंग सामान और चमड़े की निर्यात आय में कमी आना है।

अक्तूबर में देश शुद्ध तौर पर आयातक रहा। देश का व्यापार घाँटा 8.78 अरब डॉलर रहा जबकि पिछले साल इसी माह में यह 11.76 अरब डॉलर था। इस दौरान देश का आयात भी 11.56 फीसद गिरकर 33.6 अरब डॉलर रहा। वाणिज्य व उद्योग मंत्रालय ने बयान में कहा, 'देश से वस्तुओं का निर्यात अक्तूबर 2020 में 24.82 अरब डॉलर रहा। यह पिछले साल अक्तूबर के 26.23 अरब डॉलर के निर्यात से 5.4 फीसद कम है।'
