

### बुलडोजर न्याय : मनमानी पर रोक

उत्तरप्रदेश से शुरू हुआ बुलडोजर न्याय राजस्थान सहित कई अन्य प्रदेशों में भी अपराधियों को सबक सिर्जाने तथा अवैध निर्माण के ध्वस्तीकरण से अपराधियों में भय तथा जन सामान्य में त्वरित न्याय के रूप में देखा जाने लगा था। लेकिन इस कार्यवाही में मनमानी तथा रातों रात ध्वस्तीकरण जैसे प्रकरणों ने सवाल खड़े किये कि क्या किसी का पक्ष सुने बिना अथवा परिवार का कोई सदस्य अपराधी होने से अथवा अवैध तरीके से किये निर्माण को त्वरित न्याय के नाम पर ध्वस्त करना तथा अधिकारियों की मनमानी व पिछली तारीख में नोटिस जारी करना अथवा जानबूझ कर कार्यवाही के लिए ऐसा समय चुनना जब पीड़ित अदालत अथवा उपयुक्त मंच पर न्याय की गुहार भी न कर सके। इस प्रक्रिया का एक पहलू यह भी देखा गया कि बुलडोजर जाति विशेष के लोगों की सम्पत्ति पर ही चलाये जाते रहे। ऐसे में न्याय पालिका का हस्तक्षेप संविधान व न्याय की कसौटी पर खरा उतरने वाला है। सर्वोच्च न्यायालय ने देशभर में इस कार्यवाही पर रोक लगाने के साथ ही भरोसा दिलाया था कि अदालत बुलडोजर न्याय के लिए अध्ययन के बाद दिशा-निर्देश जारी करेगी। जिन्हें राज्य सरकारों व निकायों को मानना होगा । अदालत के हस्तक्षेप की प्रमुख वजह यहीं रही कि किसी भी परिवार को बेघर करके सड़क पर नहीं पटका जा सकता अर्थात पुनर्वास अथवा सुरक्षित जगह पर जाने का प्रबंध करना आवश्यक होता है लेकिन जाति विशेष के लोगों को चन चन कर ध्वस्तीकरण के निशान पर लेने ओर अधिकारियों की मनमानी पर अदालत ने विंता व्यक्त करते हुए जस्टिस गवई ने कहा कि अपना घर हो, अपना आंगन हो, इस ख्वाब में हर कोई जीता है इंसान के दिल की यह चाहत है कि एक घर का सपना कभी न छटे।

सर्वोच्च न्यायालय ने बुलडोजर कार्यवाही पर अहम फैसले ने कहा कि अगर लोगों के घर सिर्फ इसलिए ढहा दिये जाये कि वे आरोपी या दोषी है तो यह पूरी तरह असंवैधानिक है। संविधान और आपराधिक कानूनों के मुताबिक आरोपियों व दोषियों के भी कुछ अधिकार होते है पीठ ने कहा कि मनमाने तरीके से किसी का घर गिराने के एक्शन सीधे कानून की आत्मा पर चोट पहुंचाते है हमने संविधान के तहत गांरटी कृत अधिकारों पर विचार किया। ज्यो व्यक्तियों को राज्य की मनमानी कार्यवाही से सुरक्षा प्रदान करते है। कानून का शासन यह सुनिश्चित करने के लिए लोगों को एक कवच प्रदान करता है कि उनकी सम्पत्ति मनमाने ढंग से नहीं छीनी जाएगी। पीठ ने कहा कि संविधान के आर्टिकल १४२ का इस्तेमाल करते हुए बुलडोजर एक्शन को लेकर देशभर के लिए गाइड लाइन तय की है। लिखित नोटिस के बिना किसी की सम्पत्ति नहीं ढहाई जा सकती। नोटिस कम से कम १५ दिन पहले मिलना चाहिए। आदेश के खिलाफ कोर्ट का दरवाजा खटखटाने का समय मिलना चाहिए। डीएम सुनिश्चित करेंगे कि उन्हीं इमारतों को गिराया जाय जो अवैध है। नियमों का पालन किये बिना इमारत गिराने वाले अधिकारियों पर कार्रवाई होगी। उन पर जुर्माना भी लगाया जा सकता है। नुकसान की भरपाई की जा सकती है ये निर्देश सड़क, फुटपाथ, रेल पटरी, सार्वजनिक स्थल पर अवैध कब्जे के मामले में लागू नहीं होंगे। आवश्यकता इस बात की है कि दिशा-निर्देश के अनुरूप कार्यवाही होता कि दोषियों या आरोपियों को भी कानूनी बचाव व सुरक्षण का अवसर सुनिश्चित हो सके।

### थप्पड़ मार उम्मीदवार ...
