रिपोर्ट : देश को अगले वर्ष दो टीके उपलब्ध होंगे

नई दिल्ली। भारतीय बाजार में अगले साल की शुरुआत में कोविड-19 के दो टीके उपलब्ध हो सकते हैं। बर्नस्टीन की रिपोर्ट के मुताबिक, भारत ने दीड़ में आगे चल रही कंपनियों एस्ट्राजनेका और नोवावैक्स के टीके का करार पहले सुनिश्चित कर लिया है। ऐसे में टीके को मंजूरी मिलते ही भारत में इनका टीकाकरण शुरू हो सकता है।

रिपोर्ट के अनुसार, वैश्विक स्तर पर चार संभावित टीके हैं, जिन्हें 2020 के अंत तक या 2021 की शुरुआत में स्वीकृति मिलने का अनुमान है। इनमें से दो टीके एस्ट्राजनेका व ऑक्सफोर्ड का वायरल वेक्टर टीका और नोवावैक्स के प्रोटीन सबयूनिट टीके के लिए भारत ने साझेदारी की है। इन टीकों के अब तक के परीक्षण मानकों पर खरे उतरने के साथ प्रतिरक्षा क्षमता बढ़ाने में सफल साबित हुए हैं। ऐसे में भारत में 2021 की पहली तिमाही में बाजार में एक स्वीकृत टीका उपलब्ध हो जाएगा।
