Voting Rights shall be reckoned on the paid-up value of shares registered in the names of the members as on the Cut-Off Date and any person who is not a Member as on that date, should treat the Postal Ballot Notice for information purposes only.

In compliance with the provisions of the Sec.108 & 110 of the Companies Act, 2013 read with Rules made thereunder, Reg.44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended (Listing Regulations) and in accordance with the MCA Circular, the Company has engaged M/s. Central Depository Services (India) Limited (CDSL) as the Agency for facilitating remote e-voting to enable the Members to cast their votes electronically ("Remote e-voting").

The Notice of Postal Ballot alongwith the instructions for e-voting is also available on the Company's website at www.tgvgroup.com and the Voting Website of CDSL at www.cdslindia.com and on the relevant sections of website of the Stock Exchanges on which the shares of the company are listed i.e., www.bseindia.com.

In compliance with the requirements of the MCA Circular, Hard Copy of the Postal Ballot Notice alongwith the Postal Ballot Form and Prepaid Business Reply Envelope will not be sent to the Members for this Postal Ballot and the Members are required to communicate their Assent or Dissent through Remote e-voting system only. The facility to exercise vote on Postal Ballot by e-voting, will be available for the following periods.

**Commencement of the e-voting : Friday, March 11, 2022 (9.00 AM (IST))**  
**End of e-voting : Saturday, April 9, 2022 (5.00 PM (IST)).**

During this period, the Members of the Company holding equity shares either in physical form (if any) or in Dematerialised Form as on the Cut-Off Date i.e., March 08, 2022 may cast their vote electronically. The Resolutions, if passed with the Requisite Majority shall be deemed to have been passed on the last date specified by the Company for voting i.e., April 09, 2022. e-voting shall not be allowed after 5.00 PM (IST) on April 09, 2022. The e-voting module shall be disabled by CDSL for voting thereafter.
