Scrutinizer's Report

To, Chairman Mahindra CIE Automotive Limited Suite F9D, Grand Hyatt Plaza (Lobby Level) Off Western Express Highway, Santacruz (E) Mumbai 400055

Sir,

I was appointed as a Scrutinizer by the Board of Directors of Mahindra CIE Automotive Limited ("the Company"), by a Circular resolution passed on Monday, 23 January, 2023 for scrutinizing the votes cast by Postal Ballot which was carried out by electronic means through the remote e-voting facility only ("Postal Ballot"), on the item of business set out in the Notice of Postal Ballot dated Monday, 23 January, 2023. I submit my report on the result of Postal Ballot as under:

- 1. The Company completed the e-mail dispatch of Notice of Postal Ballot on Monday, 30 January, 2023. The Notice was sent to the Members whose names appeared in the Register of Members / List of Beneficial Owners as received from National Securities Depositories Limited and Central Depository Services (India) Limited as on Friday, 27 January, 2023.
- 2. The voting rights of members were considered in proportion to the paid-up value of their shares in the equity capital of the Company as on Friday, 27 January, 2023, the "cut-off date" fixed by the Company. Total number of shareholders as on the cut-off date was 99,142 holding 379,317,379 equity shares of the Company.
- 3. The Notice of Postal Ballot was sent to the e-mail IDs of Members, which were registered with their Depository Participants (in the cases of dematerialized shareholding) and with the Company's Registrar and Transfer Agent (in the cases of physical shareholding).
- 4. No printed copy of notice of Postal Ballot and Postal Ballot Form were sent to the Members and they were required to communicate their assent or dissent through remote e-voting facility only.

- 5. The e-voting module of KFin Technologies Limited was enabled on Wednesday, 1 February, 2023 at 9.00 A.M. and disabled on Thursday, 2 March, 2023 at 5.00 P.M. During this period, Members of the Company, holding shares in physical and dematerialized form, as on the cut-off date, were able to cast their vote through remote e-voting on the resolution set out in the Notice of Postal Ballot. The votes cast through electronic mode were unblocked on Thursday, 2 March, 2023 at 5.05 P.M.
- 6. Particulars of all votes cast by Postal Ballot have been entered in the register separately maintained for the purpose.
- 7. The summary of votes cast by electronic mode is given in **Annexure A.**
- 8. You may accordingly declare the result of the voting by Postal Ballot.
