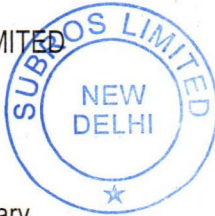


# Stride Ventures announces new fund, targets corpus of up to ₹1,875 crore

New Delhi, May 25

**INVESTMENT FIRM STRIDE** Ventures on Tuesday announced a debt fund for Indian startups with target size of up to ₹1,875 crore.

The firm will commence investing in early to late stage startups with ticket size from ₹20 lakh to ₹1 crore, Stride Ventures said in a statement.

"Stride Ventures is launching Stride Ventures India Fund I with a targeted corpus of ₹1,800 crore and a green-shoe option to raise an additional ₹75 crore," the firm said.

With this targeted corpus, Stride Ventures expects to invest ₹1,000 crore total debt funding in startups over a period of 18 months.

The new fund will have a commitment period of four years with which the capital will be deployed and recycled, the statement said.

# BPCL may sell some stake in IGL, Petronet to shed promoter status

**FINANCIAL EXPRESSION** Bharat Petroleum Corporation (BPCL) may sell part of its stake in Petronet IGL and Indraprastha Gas (IGL) to shed its promoter status to devolve the need for a new promoter to take over the two gas companies, sources said.

BPCL holds 11.8% stake in IGL and 10.2% stake in Petronet IGL. It is a promoter of the two companies and both board positions.

At present, the legal position is shared by the Ministry of Investment and Public Asset Management (IPAM) and the department handling the process. The sale of government's 53.9% stake in BPCL — the acquirer of BPCL — will have to make an open offer.

BPCL holding stake in Petronet and IGL is valued at around ₹24,000 crore in its current market value. BPCL, however, is not in favour of selling the stake and giving up promoter status and direct control will result in substantial value erosion for the company.

But the thinking in the government is that the operators for Petronet and IGL may prefer to have an independent promoter who can manage the two companies better. The government's 53.9% stake in BPCL is valued at around ₹24,000 crore in its current market value. BPCL, however, is not in favour of selling the stake and giving up promoter status and direct control will result in substantial value erosion for the company.
