Sub: Announcement under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Dear Sir/Madam,

This is with reference to our earlier announcements dated April 01, 2023 and April 05, 2023, intimating the penalty imposed by adjudication order passed by SEBI against the Company and its officers pertaining to SEBI (Prohibition of Insider Trading) Regulations, 2015 vide SEBI Adjudication Order No. Order/VV/PSS/NK/2022-23/25473-254 dated March 31, 2023. In this regard, we have received a Corrigendum dated May 03, 2023 to the said Order informing us that there was an inadvertent typographical error with respect to penalty mentioned in words imposed on Mr. Markand Adhikari. In the said Order, SEBI has erroneously mentioned the amount of penalty in words "Rupees Ten Lakhs" instead of "Rupees Twenty Lakhs".

By this Corrigendum, SEBI has rectified the amount of penalty imposed in words on Mr. Markand Adhikari to Rs. 20,00,000/- (Rupees Twenty Lakhs Only).

Further additional disclosures required pursuant to SEBI Circular no. CIR/CFD/CMD/4/2015 dated September 09, 2015, with regard to Litigation(s) / dispute(s) / regulatory action(s) with impact for the above matters is attached herewith as Annexure I.
