## India logs 1,260 fresh Covid cases, 83 deaths

PRESS TRUST OF INDIA New Delhi, April 2

**INDIA'S VIRUS TALLY** rose to 4,30,27,035 with 1,260 fresh cases being reported in a day, while the number of active infections further declined to 13,445, according to the Union health ministry data updated on Saturday.

The death toll from the pandemic climbed to 5,21,264 with 83 new fatalities, the data updated at 8 am showed.

The active cases count comprised 0.03% of the total infections, while the national Covid-19 recovery rate remained at 98.76%, the health ministry said.

A reduction of 227 cases has been recorded in the number of

active Covid-19 cases in a span of 24 hours, according to the data. The daily positivity rate was recorded at 0.24% and the weekly positivity rate at 0.23%, according to the health ministry.

The number of people who have recuperated from the disease surged to 4,24,92,326, while the case fatality rate was recorded at 1.21%.

The cumulative doses administered in the country so far under the nationwide Covid-19 vaccination drive has exceeded 184.52 crore. India's Covid-19 tally had

crossed the 20-lakh mark on August 7, 2020; 30 lakh on August 23; 40 lakh on September 5 and 50 lakh on September 16.

THE INDIAN RAILWAYS achieved its highest ever freight loading in the financial year 2021-22, it said

on Saturday. The national transporter loaded 1,418.1 MT of freight in 2021-22, which is 15% higher compared to 1,233.24 MT in 2020-21, it said in a statement.

This is the highest ever loading for the railways in a financial year and it has achieved its highest ever monthly loadings for 19 consecutive months from September 2020 to March 2022, it added.

# Tamil Nadu government revises property tax after gap of 24 years

PRESS TRUST OF INDIA Chennai, April 2

THE TAMIL NADU government on Saturday announced effecting an across-the-board revision in property tax to mop up revenue for local bodies, proposing up to 150% increase, but asserted the rates were lesser than many other states.

The main opposition AIADMK lashed out at the move, saying this was only a "trailer" and that more "bumper prizes were in store" for the people for electing its rival, the DMK, in the

DMK ally Congress also opposed the decision, saying it would further burden the people in the wake of the rising

fuel prices and called for a rethink on the mode of its implementation.

Another ally of the DMK, CPI (M), sought a rollback of the revision. Municipal administration

minister K N Nehru told reporters in New Delhi that the tax revision was effected in line with the 15th Finance

Commission guidelines and that central funds would be made available only if it was done.

According to an official release here, a number of reasons, including a manifold increase in inflation over the years, spurred the decision to effect the increase and there was a dip in the civic bodies' share of own revenue.

## Guwahati airport may get 27 more daily flights

THE LOKAPRIYA GOPINATH Bordoloi International Airport in Guwahati has planned to operate 27 additional flights per day for the summer schedule which begins on the last Sunday of March and ends on the last Sunday of October.

If everything goes as planned, the number of daily flights from the airport will increase from 63 to 90

during the period, an airport spokesperson on Saturday. New destinations likely to be added to the list

of flights include Varanasi and Durgapur. Several routes will find additional flights, with Delhi getting two while Mumbai,

Imphal and Patna will have one each in the summer schedule, she said.

#### Work, study in Australia to be easier for Indians

These cover key areas of India's interest like IT, ITES, business services, health, education and audio visual.

Some of the key offers from Australia in the services space include quota for Indian chefs and yoga teachers; post-study work visa of two-four years for Indian students on reciprocal basis; mutual recognition of professional services and other licensed/regulated occupations; and work and holiday visa arrangement for young professionals.

India has offered Australia market access in around 103 sub-sectors and MFN status in 31 sub-sectors from the 11 broad service sectors. These include business services, communication services, construction and related engineering services.

Both the sides have factored in each other's sensitivities while firming up the deal, Goyal said. New Delhi has kept its dairy sector out of the pact's purview and offered only limited access in agriculture. So, scores of sensitive farm products, such as sugar, rice, wheat, walnut, apple, pulses and oilseeds, have been excluded by India from the ambit of the agreement.

In certain cases, it has tied concession to a quantitative cap. For instance, India will allow only long-staple Australian cotton at zero duty, subject to a cap of 3,00,000 bales,

which is less than 1% of its annual domestic consumption. Australia oranges and mandarin will get preferential access only up to 13,000 tonne. New Delhi has also kept iron ore out of the pact.

Similarly, Australia will have preferential access to the Indian market in raw materials such as coal, aluminium and premium wines. New Delhi will allow Australian wine that costs between \$5 and \$15 per 750 ml at a concessional duty of 100% initially from the current 150%. The tariff will be cut by 500 basis points annually for 10 years and finally kept at 50%. Similarly, the import duty on wine beyond \$15 per 750 ml will be reduced to 75% immediately; it will then be cut by 500 basis point annually for 10 years to be kept at 25%.

Indian labour-intensive sectors, including gems & jewellery, textiles & garments, leather, footwear, furniture and food & farm products, and engineering products, medical devices and automobiles will benefit from the pact. Both sides have also agreed to a separate chapter on pharmaceutical products under this agreement, which will expedite the approval for patented, generic

and biosimilar medicines. With the clinching of the deal, both the countries are aiming to almost double bilateral trade to \$50 billion from \$27.5 billion (in 2021) in the next five years. India had an overall trade deficit of \$6.5 billion, thanks primarily to a gap in merchandise trade.

### Watershed moment, says PM

Australian PM Scott Morrison, Indian commerce and industry minister Piyush Goyal and his Australian counterpart Dan Tehan were also present at the virtual event.

Modi said the conclusion of the ECTA in a short period (negotiations were revived only on September 30, 2021) points at the depth of mutual confidence between the countries. The agreement, Modi said, will furtherbolsterthe"warm and close ties" between the people of the two countries by expanding work, study and travel opportunities, in addition to raising bilateral trade and economic cooperation.

For his part, the Australian Prime Minister said the ECTA would create ample opportunities for trade diversification for domestic producers and service providers bound for India, valued at up to \$14.8 billion a year.

The agreement is also great news for lobster fishers in Tasmania, wine producers in South Australia, macadamia farmers in Queensland, critical minerals miners in Western Australia, lamb farmers from New South Wales, wool producers from Victoria and metallic ore producers from the Northern Territory, he said.

"This agreement opens a big door into the world's fastest growing major economy for Australian farmers, manufacturers, producers and so many more," Morrison said.

In November-December, several local firms had written to the Department of Telecommunications (DoT), seeking an extension of one year. Apart from individual firms, industry body Cellular Operators' Association of India (COAI) had also sought an extension of one year on account of shortage of semiconductors as well as supply chain delays.

The objective of the PLI scheme is to boost domestic manufacturing in the telecom and networking products by incentivising incremental investments and turnover with total outlay of ₹12,195 crore. The scheme is effective from April 1,2021. Investment made by successful applicants in India from April 1, 2021, onwards and up to FY2024-25 shall be eligible, subject to qualifying incremental annual thresholds. The support under the scheme shall

be provided for a period of five years, from FY 2021-22 to FY 2025-26. Notable companies selected

under the scheme include Flextronics, Foxconn, Jabil, Nokia, Rising Star, Dixon Technologies, VVDN Technologies, Tejas Networks, HFCL, ITI, Coral Telecom and Lekha Wireless, among others. Overall, a total of 31 companies, comprising 16 MSMEs and 15 Non-MSMEs (8 domestic and 7 global companies) have been selected. The scheme offers incentives between 4% and 7% for different categories and tenures. For the MSMEs, a 1% higher incentive is proposed in year 1, year 2 and year 3. Financial year 2019-20 will be treated as the base year for computation of cumulative incremental sales of man-

ufactured goods net of taxes. The minimum investment threshold for MSMEs has been kept at ₹10 crore and for others at ₹100 crore. 
