Crude Steel Production : 12.54 lakh tonnes in October'19

JSW Steel Limited reports Crude Steel production at 12.54 lakh tonnes for October 2019.

The extended monsoon rains impacted production both at Dolvi and Vijayanagar locations. The Company has taken temporary shutdown of one of the Blast Furnaces at Salem location due to slowdown in demand from Auto Sector.
