Pursuant to Regulation 17(1C) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) (Amendment) Regulations, 2018, the appointment of Additional director (Independent category) shall be regularized within three months from the date of the appointment or date of ensuing Annual General Meeting, whichever is earlier. Accordingly, Ms. Sumeela Kasu who was appointed as an Additional Director of the Company on 01.06.2022 in terms of Section 161 (1) of the Companies Act, 2013 and provisions of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) (Amendment) Regulations, 2018 in the category of 'Non-Executive Independent Director' is required to be regularised at the earliest but not later than three months as an Independent Director of the company by way of a Special Resolution.
