হাসপাতাল সূত্রে জানা গিয়েছে, 'সদেহজনক' বিল নিয়ে রোগীকল্যাণ সমিতি সংশ্লিষ্ট ঠিকাদারদের কাছে তাদের বক্তব্য শোনার জন্য গত শুক্রবার

হাসপাতালে বৈঠক ডাকে। সেখানে ছিলেন রোগীকল্যাণ সমিতির চেয়ারম্যান তথা মহকুমাশাসক (কাটোয়া) প্রশান্তরাজ গুপ্ত, হাসপাতালের সুপার নবরঞ্জন গুপ্ত। সমিতির সদস্য তথা কাটোয়ার বিখ্যাত রবীন্দ্রনাথ চট্টোপাধ্যায়ের প্রতিনিধি হিসেবে ছিলেন প্রাক্তন কাউন্সিলর সুদীপ্তময় ঘোষ। ঠিকাদারদের কাছে বিল নিয়ে বক্তব্য শোনা হয় ও উপযুক্ত নথিপত্র চাওয়া হয়। হাসপাতাল সূত্রে দাবি, কয়েকজন ঠিকাদার বিলের পক্ষে উপযুক্ত নথি দেখাতে না পারায়, অসন্তোষ প্রকাশ করেন।

আধিকারিকেরা। বিখ্যাত রবীন্দ্রনাথবাবু বলেন, 'হাসপাতালের নানা কাজের জন্য প্রায় চার কোটি টাকা পাওনা বলে ঠিকাদারেরা দাবি করছেন। বিষয়টি আমাদের সদেহজনক মনে হওয়ায় বৈঠকে ঠিকাদারদের কথা শোনা হয়েছে। আমরা চাই, সরকারি কোথাগোত্রের টাকা নিয়ম মেনেই খরচ করা হোক।' হাসপাতালের সুপার নবরঞ্জন গুপ্তের বক্তব্য, 'নানা কাজের জন্য মোটা টাকা দাবি করেছেন ঠিকাদারেরা। বিষয়টি আমরা খতিয়ে দেখছি। উর্ধ্বতন কর্তৃপক্ষকেও তা জানানো হয়েছে।'
