**Sub: Clarification on Price Movement** 

Dear Sir,

This is with reference to your email as referred above, we would like to inform that there is no price sensitive information with a bearing on the operation/performance of the Company, which is unpublished and is pending to be intimated/ disseminated by the Company to the Stock Exchanges, as per the terms of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended) (the "SEBI LODR Regulations").

As you may be aware, A2R Holdings (along with its persons acting in concerns, ARR Studio Private Limited and Namit Malhotra) has initiated an open offer to the public shareholders of the Company, to acquire up to 26% shares from such shareholders (the "**Open Offer**"). In respect to such Open Offer, kindly note that:

- 1. The Company has sent intimation letters to the Stock Exchanges on December 25, 2020, January 1, 2021, January 9, 2021, February 12, 2021, February 18, 2021 and February 22, 2021;
- 2. At the time of public announcement on December 24, 2020, the equity shares of the Company were infrequently traded, and to such extent the offer price under the Open Offer has been determined based on the requirements set out under the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, and appropriate disclosures to this effect have been included in the Public Announcement, the Detailed Public Statement, the Draft Letter of Offer and the Letter of Offer, issued in relation to the Open Offer. Please see **Annexure A** on volume of trades in the shares in BSE and NSE from December 1, 2019 to November 30, 2020.



- 3. Reliance Mediaworks Financial Services Private Limited and Reliance Capital Limited, as well as one Anupkumar Sheth (a shareholder of the Company), filed appeals before the Hon'ble Securities Appellate Tribunal ("SAT"), against the Securities and Exchange Board of India, IDBI Trusteeship Services Limited, Credit Suisse A.G. Keynote Financial Services Limited (Merchant Banker to the Open Offer), A2R Holding (Acquirer in the Open Offer), ARR Studio Private Limited (PAC 1 in the Open Offer), Namit Malhotra (PAC 2 in the Open Offer) and the Company alleging, inter alia, that the fair value of shares of the Company in the Open Offer, which was computed for the purposes of determining the Open Offer price was not correct. - 4. The Hon'ble SAT has heard detailed arguments of all parties in relation to the aforesaid appeals, and on March 3, 2021, reserved the matters for further orders, with a direction that the Open Offer is subject to the final outcome of the appeals. An intimation letter has been issued by the Company to the Stock Exchanges, on March 4, 2021, for public dissemination in this respect.

We would like to reiterate that the Company is committed to comply with its disclosure requirements set out in the SEBI LODR Regulations.

Provided that where the share capital of a particular class of shares of the target company is not identical throughout such period, the weighted average number of total shares of such class of the target company shall represent the total number of shares.
