We are pleased to inform you that the Board of Directors of the 360 ONE WAM LIMITED (Formerly known as IIFL Wealth Management Limited), at its Meeting held on July 20, 2023, has declared second interim dividend for the financial year 2023-24, of Rs. 4/- (Rupees four only) per equity share of Re. 1/- (Rupee one only) each.

Pursuant to the changes introduced by the Finance Act, 2020, w.e.f. April 1, 2020, the Company is required to withhold taxes at the prescribed rates on the dividend paid to its shareholders. Incomplete and/or unsigned forms, declarations and documents will not be considered by the Company for granting any exemption.

It may be further noted that in case the tax on said dividend is deducted at a higher rate in absence of receipt of the aforementioned details/documents from you, there would still be an option available with you to file the return of income and claim an appropriate refund, if eligible.
