Dear Shareholder,

This is to inform you that SEBI vide its aforesaid Circulars has mandated:

- a) furnishing of PAN, email address, mobile number, bank account details and nomination by holders of physical securities;
- b) any service request shall be entertained by the Company or the Registrar and Shares Transfer Agent ("RTA") only upon registration of security holder PAN, Bank details and the nomination (w.e.f. January 1, 2022);
- c) to ensure that security holder PAN is linked with his/her Aadhaar Card by March 31, 2022 or any other date as may be specified by the Central Board of Direct Taxes to avoid freezing of folio.
