পরপর কন্যা সন্তান হওয়ার ঘটনায় গৃহবধূকে খুনের অভিযোগ উঠলো স্বামীর শশুরবাড়ির বিরুদ্ধে



দুর্ভাগ্য বার্তা, মালদা, ১১ আগস্ট : কেন্দ্র হোক বা রাজ্য, একদিকে যেমন শ্লোগান রয়েছে 'বেটি বাঁচাও, বেটি পড়াও', অন্যদিকে টিক একইভাবে কন্যাস্ত্রীর মাধ্যমে মেয়েদের স্বনির্ভর করার লক্ষ্য রয়েছে সরকারের। কিন্তু এবারে মালদায় উঠে এলো এক রোমহর্ষক ঘটনা। পরপর তিনটি কন্যা সন্তান হওয়ার ঘটনায় গৃহবধূকে নৃশংস অত্যাচার চালিয়ে খুনের অভিযোগ উঠলো স্বামীর শশুরবাড়ির লোকদের বিরুদ্ধে।

অভিযুক্ত স্বামী আব্দুল হান্নান। গত সাত বছর আগে মালদা জেলার বখুয়া থানার আলিপুরা বাসিন্দা রফিকুল আলমের মেয়ে ছবিনা খাতুনের বিয়ে হয় পাঁচ পারা কলোনির যুবক আব্দুল হান্নানের সাথে। বিয়ের পরেই কন্যা সন্তান জন্ম নেয় তাদের পরিবারে। তখন থেকেই গৃহবধূর ওপর অত্যাচার শুরু করে স্বামীর শশুরবাড়ির সদস্যরা। পরপর আরো দুই কন্যা সন্তান হলে আরও অত্যাচার বেড়ে যায় বলে গৃহবধূর পরিবারের সদস্যরা জানিয়েছেন। বৃহস্পতিবার রাতে গৃহবধূকে মারধর করে এমন কি গরম লোহার রড দিয়েও ছাঁকা দেওয়া হয়। এরপরই শ্বাসরোধ করে খুন করে বলে অভিযোগ তোলে মৃত গৃহবধূর পরিবারের সদস্যরা। মৃত্যুর পরেই একাধিক জয়গায় আঘাতের চিহ্ন পেয়েছে পুলিশ। মৃত্যুর এক সাত্মীয় সাহিনা বিবি জানিয়েছেন, বৃহস্পতিবার তার বোনের ওপর অত্যাচারের কথা মোবাইলে জানিয়েছিল। এরপরই রাতে জানতে পারি বোনের মৃত্যু হয়েছে। আমরা পরিবার থেকে সকলেই শশুরবাড়ির ছুটে গেলে দেখি বাড়িতে বোনের মৃতদেহ পড়ে রয়েছে। লোকজন কেউ নেই। এরপরই পুলিশকে খবর দেওয়া হয়। বৃহস্প অত্যাচার চালানোর পর সাতশত করেই ছবিনাকে খুন করা হয়েছে। এদিকে তদন্তকারী পুলিশ কর্তারা জানিয়েছেন, মৃতদেহটি ময়নাতদন্তের জন্য মালদা মেডিকেল কলেজে পাঠানো হয়েছে। ময়নাতদন্তের রিপোর্ট পাওয়ার পরই মৃত্যুর প্রকৃত কারণ সম্পর্কে বলা যাবে। তবে ওই গৃহবধূর শরীরে কয়েকটি জয়গায় ক্ষতচিহ্ন দেখা গেছে। তাতে মনে করা হচ্ছে ওই মহিলার উপর অত্যাচার হতে পারে। মৃতের পরিবারের পক্ষ থেকে পাঁচ জনের বিরুদ্ধে লিখিত অভিযোগ দায়ের হয়েছে। ঘটনার পর থেকেই অভিযোগ পলাতক অভিযুক্তরা তাদের খোঁজ চালানো হচ্ছে।
