TikTok sale to Walmart, Oracle stalls as Biden reviews security

This comes as TikTok's parent, ByteDance, finds itself in a legal tussle with the US government, with many federal courts barring the Commerce Department's attempt to shut down TikTok's operations in the United States.

Discussions have continued between representatives of ByteDance and US national security officials, the WSJ report said, citing people familiar with the matter. TikTok has been in talks with Walmart and Oracle since September to finalize a deal that would shift TikTok's US assets into a new entity to prevent its total ban on use in the country.

Quad key example of US, partners pulling together for free and open Indo-Pacific: US

The Quad, or the Quadrilateral Security Dialogue, is an informal grouping of four countries -- Australia, India, Japan and the United States. It is aimed at ensuring a free and open Indo-Pacific, a strategically vital region that witnessed increasing Chinese military assertiveness in recent years.

"What I would say generally is that the Quad is a key example of the United States and our closest partners, including, in this case, India, pulling together for the good of a free and open Indo-Pacific region," State Department Spokesperson Ned Price told

reporters at his daily news conference on Tuesday.
The evolving situation in the Indo-Pacific region in the wake of China's increasing military muscle flexing has become a major talking point among leading global powers. The US has been favouring making Quad, comprising a security architecture to check China's growing assertiveness. China is engaged in hotly contested territorial disputes in the South and East China Seas. Beijing has also made substantial progress in militarising its man-made islands in the past few years.

लोग टीकाकरण के प्रति सकारात्मक : सर्वे

जनसत्ता संवाददाता नई दिल्ली, 10 फरवरी।

कोविड-19 टीकाकरण पर 1 एमजी और ब्रीफ की ओर से मिलकर किए पायलट सर्वेक्षण के मुताबिक 84 फीसद लोगों ने टीकाकरण की इच्छा जताई जबकि बाकी लोगों में साइड इफेक्ट को लेकर चिंता पाई गई। ऑनलाइन सर्वे में 3392 लोगों ने हिस्सा लिया। जिनसे मिली राय के आधार पर यह आंकड़े सामने आए हैं। टीका नहीं लेने की मानसिकता रखने वाले 16 फीसद लोगों में से 36 फीसद को साइड इफेक्ट का डर है। जबकि 42 फीसद लोग टीकाकरण के लिए 500 तक खर्च करने के लिए तैयार हैं।

यह सर्वे दिसंबर 2020 से जनवरी 2021 के बीच किया गया। सर्वे में पता चला कि लोगों में टीकाकरण के प्रति सकारात्मकता है। इनमें से 28 फीसद परिवार के सदस्यों के कमजोर रहने के चलते टीकाकरण के इच्छुक दिखे, तो 22 फीसद ज्यादातर समय सार्वजनिक स्थानों पर रहने के कारण टीका लेने का चयन किया। कुछ लोग कीमती के अनुसार टीका चाहते हैं। सर्वे में शामिल 42 फीसद लोग केवल 500 रुपए तक ही खर्च करना चाहते हैं।
