WITH THE Navratri celebrations kicking off on October 3, the Gujarat police has swung into action, issuing advisory and guidelines for organisers and participants to ensure that no untoward situation arises during the nine nights of Garba festivities. While the Ahmedabad police has issued an advisory against "sheer" and "indecent' clothing, Surat police has asked organisers to "not take law in their hands" in dealing with any suspicious persons at the venues

On Friday, putting out a 30point advisory, the Ahmedabad city police specifically mentioned "sheer" and "indecent" clothes, cautioning patrons not to dress in an "obscene" manner. The notification, in Gujarati, does not describe what makes "inde-

CATARACT SURGERIES AT RAJKOT HOSPITAL UNDER SCANNER

OT sealed as 10 patients develop complications

GOPALKATESHIYA RAJKOT, SEPTEMBER 28

THE OPERATION theatre of an eye hospital in a village of Rajkot has been sealed by the Health Department after 10 patients who recently underwent cataract surgery at the hospital developed complications, officials said on Saturday

Dr PK Singh, Chief District Health Officer (CDHO), Rajkot, said that his team sealed the operation theatre of the Shivanand Mission Eye Hospital (SMEH) in Virnagar village on Thursday night after the incident came to light.

"The hospital performed 32 cataract surgeries on September 23. During dressing, the staff detected unusual secretion of fluids from the eyes of nine of 32 patients. Samples were taken and sent to a laboratory in Rajkot while the patients were treated for bacterial infection. Laboratory tests confirmed bacterial infection among patients. After the incident was reported to us, we visited the hospital on Thursday and sealed the OT," Dr Singh told The Indian Express on Sunday.

After the confirmation of bacterial infection, these nine patients were shifted to Rajkot Civil Hospital on Friday morning. "Of them, four had severe infection while five had mild infection," the CDHO said, adding, "After the confirmation of the infection, the hospital reached out to 23 other patients who were operated upon on September 23 and asked them if they had any complications. During this exercise, they concluded that one patient from Botad also had developed complications, taking the number of infected patients to 10."

Dr Singh further said that primary laboratory tests of samples taken from equipment in the OT have returned negative for the presence of bacteria. "Also, cataract surgeries were performed in the same OT on September 24 and 25 and no postsurgical complications have been reported among those patients. This can mean that these patients could have contracted infection before cataract surgeries or post surgery. To identify the source of infection, a five-member expert team comprising eye surgeons and microbiologists from the department health in Gandhinagar visited the hospital

While we are trying to identify source of the infection, our trustee Dr (Chhotelal) Verma, who is also a senior doctor, is in Rajkot to ensure that patients get best treatment and their eyesight can be saved," he said, adding, "Patients had to be shifted to Rajkot civil hospital for treatment after OT of our hospital was sealed." Meanwhile, Dr Hetal Kvada. media coordinator of Rajkot Civil Hospital, said that seven of the nine affected patients were referred to Ahmedabad Civil Hospital on Saturday as they had severe infection.

IIM STUDENT'S FATHER FILES COMPLAINT

Cops say no evidence yet of abetment to suicide

BRENDAN DABHI AHMEDABAD, SEPTEMBER 28

DAYS AFTER a 24-year-old MBA student was found dead inside his hostel room at the Indian Institute of Management Ahmedabad (IIMA), the police have said that, prima facie, they have not found anything to suggest that there was any instance of abetment to suicide.

This comes a day after the father of Akshith Bhukya, who is from Warangal in Telangana, lodged a written complaint with police, requesting them to look into allegations that the secondyear student had been pressured and threatened by an administrative staffer at the prestigious institute over an upcoming symposium.

Police, however, told The Indian Express that they have not found any evidence yet to support the allegations. "This case still remains an accidental death one," a police official said.

Investigating officer RL Patel said Bhukya was heading the coordination committee of The Red Brick Summit (TRBS), IIMA's annual management symposium. The committee had brought in sponsorship from a third-party firm. "The company was going to hold an advance event as part of the deal. However, this company allegedly used an IIMA logo in their promotional material and uploaded it on social media platforms This is said to have rankled senior officials at the premier institute," an officer con-

nected with the case said. The police officer said that one of the administrative

staffers told another member of the coordination committee that the company did not have the authority to use the IIMA logo. They were asked to pull it down from social media and cancel the event, the officer added.

"Following this, the firm deleted the posts and the event was cancelled. The entire controversy had ended by September 20. Later on, this staffer texted a member of the coordination committee that they should be more careful in the future, especially regarding the use of the IIMA logo by third parties," the police officer said.

"We have found no evidence to support the allegations that Bhukya took the extreme step following pressure from the administrative staffer," Patel said.
