In accordance with SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information in terms of Regulation 8 of SEBI (Prohibition of Insider Trading) Regulations, 2015, we would like to intimate the following:

- The Bank's CASA deposits aggregated to ₹ 67,132 Crore, a growth of 15.0% over ₹ 58,370 Crore as of \triangleright March 31, 2021. CASA ratio reached 36.94% (FY22) from 33.81% (FY21).
- The Bank's Retail deposits as per internal classification aggregated to ₹ 1,71,569 Crore, a growth of 10.0% over ₹ 1,55,977 Crore as of March 31, 2021. Retail deposits share improved to 94% from 90% as of March 31, 2021. Total deposits aggregated to ₹1,81,712 Crore, a growth of 5.3% over ₹1,72,644 Crore as of March 31, 2021.
- The Bank's gross advances grew by 9.5% to ₹ 1,47,644 Crore from ₹ 1,34,877 Crore as of March 31,2021. As per internal classification, Retail credit book grew by 10.4% and wholesale credit book grew by 8.3%. Retail to wholesale ratio improved to 55:45 (FY22) from 54:46 (FY21).
