Pursuant to the provisions of Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014 as substituted by the Companies (Management and Administration) Amendment Rules, 2015 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirement) Regulations, 2015, the Company is pleased to provide its members with the facility to exercise their right to vote on the agenda items as stated in the notice of the Annual General Meeting by electronic means and the business may be transacted through the e-voting services provided by National Securities Depository Limited (NSDL).

The details pursuant to the provisions of Section 108 of the Companies Act, 2013 and the relevant Rules prescribed there under are as follows:

1. The business may be transacted through voting by electronic means.

2. Date and time of commencement of remote e-voting: Sunday, 15th September, 2019 (9.00 a.m.)

3. Date and time of end of remote e-voting: Tuesday, 17th September, 2019 (5.00 p.m.).

4. Cut-off Date: Wednesday, 11th September, 2019.

5. Any person, who acquires shares of the Company and becomes a member of the Company after dispatch of notice and holding shares as of the cut-off date i.e. 11th September, 2018 may obtain the login ID and password by sending an e-mail to evoting@nsdl.co.in by mentioning his Folio No. / DP ID and Client ID No. However, if any Member is already registered with NSDL for remote e-voting, then he can use his existing User ID and password for casting his vote. If he forgets his password, he can reset password by using "Forgot User Details / Password" option available on www.evoting.nsdl.com or contact NSDL at the following Toll Free No: 1800 222 990.

6. E-voting by electronic mode shall not be allowed beyond 5.00 p.m. on Tuesday, 17th September, 2019.

7. The facility for voting through ballot paper shall be made available at the AGM and the members attending the meeting who have not cast their vote by remote e-voting shall be able to exercise their right at the meeting through ballot paper.

8. The members who have cast their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.

9. Members of the Company holding shares either in physical form or in dematerialized form as on the cut-off date of 11th September, 2019 only shall be entitled to avail the facility of remote e-voting as well as voting at the Annual General Meeting.
