# <u>Summary of proceedings of the 57<sup>th</sup> Annual General Meeting ('AGM/Meeting')</u>

The 57<sup>th</sup> AGM of the shareholders of Andhra Paper Limited ('the Company') was held on Thursday, August 12, 2021 at 12:00 Noon (IST) through Video Conferencing ('VC')/Other Audio-Visual Means ('OAVM'). The Meeting was conducted in accordance with the circulars issued by the Ministry of Corporate Affairs ('MCA') and the Securities and Exchange Board of India ('SEBI').

Mr. Shree Kumar Bangur, Chairman & Managing Director, chaired the Meeting. The Chairman & Managing Director welcomed the shareholders to the Meeting and on requisite quorum being present, called the Meeting to order. He informed that the Company has made all the feasible efforts under the circumstances, to enable Members to participate and vote on the items being considered at the Meeting and thanked the participants for joining the meeting virtually.

The Chairman & Managing Director welcomed the Directors who participated in the Meeting through VC from their respective locations and introduced them to the Members. He informed that all the Directors joined the Meeting. He also informed that Mr. Aravind Matta, Company Secretary & Vice President (Corporate Affairs) joined the Meeting through Video Conference.

The Chairman & Managing Director informed the Members that, representatives of M/s. Deloitte Haskins & Sells, Statutory Auditors and M/s. D. Hanumanta Raju & Co, Secretarial Auditors and Scrutinizers for the remote e-voting and the e-voting during the proceedings of the AGM, were also present at the Meeting through VC.

Mr. Aravind Matta, Company Secretary & Vice President (Corporate Affairs), briefed the Members on the details relating to their participation at the Meeting through audio visual means.

He informed that since there was no physical attendance of Members and in compliance with the Circulars issued by the MCA and SEBI, Members were informed that the requirement of appointing proxies was not applicable.

With the consent of the Members present, the Notice convening the AGM and the Auditor's Report for the financial year ended March 31, 2021 were taken as read. Mr. Aravind Matta, Company Secretary & Vice President (Corporate Affairs) informed that there were no qualifications, observations or adverse remarks in the Statutory and Secretarial Auditor's Reports.
