# SUMMARY OF PROCEEDINGS OF 30th ANNUAL GENERAL MEETING

The 30th Annual General Meeting (AGM) of the Members of the Company was held on 30th September, 2024 at 4.00 P.M. (IST) through Video Conference (VC) / Other Audio Visual Means (OAVM).

Mr. Pratik R. Kabra, Chairman of the Company, chaired the proceedings of the Meeting.

The number of shareholders as on record date 23rd September, 2024 were 827.

The Chairman called the meeting to order as requisite quorum was present. The Chairman introduced the Directors, Management Committee Members and the invitees present at the meeting.

The Chairman then informed the Members that the Report of Board of Directors, the Accounts for the Financial Year ended 31st March, 2024 were taken as read as the same had already been circulated to the Members. As there were no qualifications in the Statutory Auditors Report & Secretarial Audit Report, it was not required to be read.

The Chairman then requested Ms. Rihanna Advani, Company Secretary to explain and read the detailed voting procedure at the Annual General Meeting for the Members.

The Company had appointed Mr. Nikhil R. Suchak, Practising Company Secretary (FCS: 13289 and COP No.: 18938) as the Scrutinizer for the purpose of scrutinising the process of remote e-voting held prior and e-voting during the AGM.

On the invitation of the Chairman, Members who had registered themselves as speakers, addressed the Meeting through VC / OAVM and sought clarifications on the Company's accounts and businesses. The Chairman responded to the queries of the Shareholders and provided clarifications.

Thereafter, the Chairman announced for voting to be conducted electronically (e-voting) and requested Mr. Nikhil Suchak, Practising Company Secretary, the Scrutinizer for the orderly conduct of the e-voting.

The Chairman announced that the e-voting results along with the consolidated Scrutinizer's Report shall be informed to Stock Exchanges and also be placed on the website of the Company, NSDL and Stock Exchanges. The meeting concluded at 04:10 P.M. (IST) after being open for 15 minutes for evoting to be completed.

Post completion of the Annual General Meeting, after scrutiny of votes the Scrutinizer submitted his Report to the Chairman. As per the report submitted by the Scrutinizer considering the consolidated results of the remote e-voting held prior and e-voting during the AGM, all resolutions embodied in the Notice of AGM dated 30th September, 2024 were passed with requisite majority.
