Anuj Poddar Resigns as MD and CEO of Bajaj Electricals

Bajaj Electricals Limited today announced the resignation of its Managing Director and CEO, Anuj Poddar, who shall be moving on to pursue an external opportunity. The Board has accepted his resignation while recognising and acknowledging Anuj's stellar contributions in formulating the transformation and growth journey of the Company over the past five and a half years. His last date with the company shall be 30th September, 2024.

Anuj led the organisation through a tumultuous phase and has been the architect of its overhaul and turnaround. A visionary leader, he has been instrumental in rolling out multiple transformative initiatives across the organisation, streamlining the corporate structure, strengthening the leadership team, consolidating the balance sheet, demerging the EPC business and bringing in a consumer-first approach, while driving a long-term growth strategy.
