Dear Sir/ Madam,

In accordance with Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023, and in continuation of our letter dated 12th July 2024 regarding the imposition of a fine under Regulation 33, we wish to update you on the status of the fine imposed by the exchange.

As previously disclosed, we had been informed of the imposition of a fine of Rs. 1,40,000 + GST by the exchange. Following this, and under the advice of the exchange, we had submitted an application for the waiver of the fine.

We would like to confirm that the entire fine levied by the exchange was duly paid by the company on 6th January 2025. Subsequently, we submitted an additional application on 7th January 2024, requesting a waiver of the fine.

Further, as of today, 21st February 2025, we have received an email from the exchange confirming that the application for waiver has not been approved by the "Internal Regulatory Oversight and Review Group." While the fine had already been settled earlier, we were awaiting the acceptance of our waiver request. We now confirm that there are no outstanding fines pending with the exchange.
