I, Chandran Ratnaswami (DIN: 00109215), Director of Go Digit General Insurance Limited, hereby tender my resignation as Director of Company from end of day of 30th June 2024.

IRDAI/F&I/CIR/MISC/82/5/2024) dated 22nd May 2024 the maximum age limit for Non-Executive Directors of the Board, is capped at 75 years and after attaining the age of 75 years, no person shall continue on the Board of an insurer. Provided that in cases where the Non-Executive Director has already attained the age of 75 years as on the date of issue of the circular, such insurers shall appoint new incumbent in place of such Non-Executive Director by 30th June, 2024. I have attained age of seventy-five (75) years on 11th May 2024. I have been informed by the Company that Company had made representation to Insurance Regulatory and Development Authority of India ("IRDAI" or "Authority") requesting the Authority to allow continuation my present term of directorship as approved by the Shareholders. However, IRDAI vide email dated 20th June 2024 has not acceded to the request of the Company. Therefore, I have decided to tender my resignation from the directorship of the Company.
