In case of delay in submission of Performance Security, if any, you may seek extension of time for a period not exceeding 60 (Sixty) days in accordance with Clause 2.21 of RFP.
3. Also, as per Clause 20.2 of the Contract Agreement, the Contractor shall by notice furnish to the Authority, in reasonable detail, information in respect of the insurances that it proposes to effect and maintain in accordance with the Article 20 within 30 (thirty) days of receipt of this Letter of Acceptance (LOA).

4. In case of failure of submission of Performance Security (if any) and Security against Damages (if any) within the additional 60 (Sixty) days' time period, the award shall be deemed to be cancelled and action shall be initiated by the Authority as per Clause 2.21 of the RFP.

5. It is to be noted that, in case where any part of the scope of work is being undertaken by any other Government Authority or is under purview of any other agreement, then such part of the scope of work may be liable to be descope. The Contractor shall have no claim regarding such descope / reduction in scope.
