Increasing number of Bangladeshi Muslim insurgents descending on Maharashtra is a matter of concern from a security point of view not only for the State but also for the entire nation. As per an estimate, a whopping 15 core Bangladeshi Muslims have infiltrated in India and found their way to the North East Indian States, West Bengal, Bihar and Maharashtra besides many other states. This infiltration has changed the demography of many parts of the state. Moreover, since these insurgents have succeeded in obtaining bogus documents such as Indian

Besides, BanglaDeshi infiltrators have been caught in various parts of the State including Chiplum in Konkan. Notably, most of the arrested infiltrators were found possessing bogus Indian passports.
