With reference to the captioned subject, we would like to inform you that the Bombay High Court on Monday, July 29, 2024, passed an order in respect of trademark infringement suit against the Patanjali Ayurved Ltd and imposed ₹4.5 crore costs on Patanjali Ayurved Ltd. for alleged violation of its 2023 ad-interim order that restrained Patanjali from selling camphor products.
