Subject: Qualified Institutions Placement of Equity Shares of face value of ₹1 each (the "Equity Shares") by Mankind Pharma Limited (the "Company") under the provisions of Chapter VI of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the "SEBI ICDR Regulations"), and Sections 42 of the Companies Act, 2013 (including the rules made thereunder), as amended (the "Issue")

Further to our earlier communication dated December 16, 2024 and December 19, 2024 on the captioned subject, we wish to inform you that the Fund Raising Committee of Directors of the Company at its meeting held today i.e. December 20, 2024 approved the allotment of 1,19,04,761 Equity Shares of face value of $\gtrless1$ each to the eligible Qualified Institutional Buyers at the issue price of $\gtrless2,520/$ - per Equity Share, i.e. at a premium of $\gtrless2519/$ -per Equity Share aggregating to $\gtrless29,99,99,97,720/$ - pursuant to the Issue.

Consequent to the aforesaid allotment, the paid-up share capital of the Company has increased from \gtrless 40,06,62,138 consisting 40,06,62,138 Equity Shares to \gtrless 41,25,66,899 consisting 412566899 Equity Shares having face value of Re. 1/- each. The new shares shall rank pari pasu with the existing shares.
