Subject: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations, 2015')

Pursuant to Regulation 30 read with Schedule III of the SEBI Listing Regulations, 2015, this is to inform you that the Company has received an Order from the **Office of the Commissioner of Customs & Central Tax Appeals - II Hyderabad Commissionerate** issued a favorable order (i.e., w.r.t. flavoured milk issue) dated 24 January 2025 received through email on 30 January 2025.

The demand order alleging classification of flavored milk under GST Tariff Heading No. 2202 9930, attracting a tax rate of 6% CGST and 6% SGST (IGST 12%). Consequently, it sought a differential GST liability of ₹3.09Crs for the period from July 2017 to October 2021, along with a penalty of ₹3.09Crs plus applicable interest. The Company has paid an amount of ₹3.09 Crs under protest without prejudice to the rights and contentions of the law

The Company had filed a Appeal before the **Office of the Commissioner of Customs & Central Tax Appeals - II Hyderabad Commissionerate** challenging the demand order on 20-11-2023, After reviewing the matter, the **Appellate Authority** ruled that flavored milk falls under Tariff Heading No. 0402 9990, which attracting the tax rate of 2.5% CGST and 2.5% SGST (IGST 5%). Accordingly, the **Appellate Authority** set aside the demand for differential GST, penalties, and interest.

The Company is in the process of claiming a refund of Rs. 3.09 Crores as per order passed by the Appellate Authority.
