Stalin announces medals for over 3,000 policemen, other uniformed services personnel

CHENNAI: Tamil Nadu Chief Minister MK Stalin has issued an order to award 'Tamil Nadu Chief Minister's Constabulary Medals' to 3,000 state police personnel on the occasion of Pongal. The police personnel are in the ranks of Grade-II Police Constables, Grade-I Police Constables, Head Constables, and Special Sub-Inspectors of Police.



Additionally, 'Tamil Nadu Chief Minister's Medals' will be presented to 120 fire and rescue services personnel in the rank of Leading Firemen, Driver Mechanic, Firemen Driver (Upgraded Driver Mechanic) and

Fireman (Upgraded Leading Fireman). 60 prisons and correctional services personnel too will be awarded.

They occupy ranks of Grade-I Warders (Men), Grade-II Warders (Men), and Grade II

CM Stalin launches test drive of electric SUV designed, developed in TN

CHENNAI: Tamil Nadu Chief Minister M K Stalin flagged off the test drive of Mahindra's electric SUV designed and developed in Tamil Nadu at an event held at the Secretariat here on Monday.

Mahindra launched its BE 6e priced at Rs 26.9 lakh (ex-showroom) and XEV 9e for Rs 30.5 lakh (ex-showroom) at Cheyyar and Chengalpattu in November 2024. The SUVs would be available for test ride from January 14, President - Automotive Product Development, Mahindra & Mahindra Ltd, and Joint Managing Director, Mahindra Electric Automobile Limited, R Velusamy, said.

"The BE 6e and XEV 9e are the next Indian icons that will be world beaters. These two products were built on our grounds and have several features, including inbuilt sensors which aid in stopping the vehicle to avoid hitting any object," Velusamy told reporters. Besides, it alerts the driver if his eyeballs are taken away from the road while

driving the car, he said, and added that the SUV is equipped with 12 ultra sonic sensors, 6 cameras, and 5 radars.

The battery gets charged up to 80 per cent within 20 minutes and the vehicle can travel up to 500 km on a single charge. "There's lifetime battery warranty for both 79 kWh and 59 kWh battery packs. The SUV has virtual parking facility... Mahindra's electric SUV, designed and developed in Tamil Nadu, has so many features," he said. The chief minister flagged off the test drive of Mahindra's electric luxury cars in the presence of state Industries Minister T R B Rajaa, Velusamy, and other officials. The carmaker said the BE 6e, with its sporty, performance-driven appeal, is crafted for explorers and achievers who love pushing boundaries, embodying the thrill of adventure and precision. The XEV 9e, on the other hand, redefines indulgence, offering unparalleled luxury with refined elegance.

DMK govt has failed women again, says EPS over sexual assault on inpatient in GH

CHENNAI: Taking a strong exception to the incident of a man sexually harassing a woman inpatient at a government hospital in the city on Monday, the Leader of Opposition Edappadi K Palaniswami charged that the DMK government has failed to ensure women's safety in the State. In a post on his social media handle, the AIADMK general secretary referred to the sexual assault of the Anna University student and said there had been another incident inside a government hospital in Chennai, exposing that there is no safety for women under the



"Stalin-model govern-

ment." "The CM spoke about women's safety in the Assembly, and I wonder what he will say now," Palaniswami added. Urging stringent action against the offender who allegedly harassed the woman inpatient, Palaniswami said that the CM is annoyed when we ask

him, 'Who is that sir?' He pointed out the AIADMK's 'Save Our Daughters' campaign following the student's sexual assault at Anna University. "More 'sirs' are being created as more 'sirs' are being protected in the present regime," he claimed. The AIADMK leader is turning the heat on the State government even as the DMK regime is trying to salvage its sheen by bringing in a stringent amendment to the Tamil Nadu Women Harassment Act to ensure more severe punishments for persons committing crimes against women and children.
