01	Name of the authority	Supreme Court of India upheld the award of the Central Government Industrial Tribunal (CGIT)
02	Nature and details of the action(s) taken or order(s) passed	CGIT, Mumbai vide its Order dt. 31.03.2011, directed SCI to absorb and regularize Canteen workers of LalBavta Union who are still in job as on date, subject to having been medically fit and below the age of superannuation. SCI challenged the said order before Hon'ble Bombay High Court and thereupon filed an SLP and a Review Petition before Hon'ble Supreme Court. The Supreme Court vide Order dt. 27.01.2025 dismissed the case with directions to implement CGIT Order.
