<u>Sub:</u> Disclosure pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations").

Dear Sir/ Ma'am,

Pursuant to Regulation 30 read with Clause no. 20 of Para A of Part A of Schedule III of the Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 ("SEBI Circular"), this is to inform that in the ongoing litigation between Honasa Consumer Limited ("Company") and RSM General Trading LLC ("RSM") where RSM had filed a lawsuit in the Dubai Court ("Dubai Court") for unlawful termination of its distributorship by the Company. In furtherance of the same, the Dubai Court on 06th June 2024, upon RSM's precautionary attachment application, allowed to attach the Company's assets in UAE, however, it categorically rejected to cancel the trading license of Honasa Consumer General Trading LLC ("Honasa Dubai Entity") ("Precautionary Attachment Order"). Both the Company and RSM filed respective grievances against the Precautionary Attachment Order which were rejected by the Dubai Court on October 1, 2024 ("Dubai Court Order"). The Company and RSM further appealed the Dubai Court Order before the Court of Appeals ("Appeal Court").

The Company is now in receipt of judgment dated December 10th 2024 (received on December 22, 2024 at 12:16PM IST) passed by the Appeal Court wherein the Appeal Court has rejected the appeals filed by both the Parties and has ordered to attach assets of the Company in UAE and refused to cancel the trading license of Honasa Dubai Entity ("**Appeal Court Order**"). However, this Order stands unenforceable since the Hon'ble Delhi High Court ("**Delhi High Court**") had directed RSM to file a request before the Appeal Court for suspension of the precautionary attachment proceedings ("**Delhi High Court Order**"). Appeal Court, upon RSM's request, suspended the precautionary attachment proceedings. **There shall be no material financial impact on the Company, due to (a) the Delhi High Court Order and, (b) since the Company (Honasa Consumer Limited) has no assets located in UAE.**

We also find it imperative to clarify here that the Delhi High Court had allowed Section 9 petition and granted anti-enforcement injunction to the Company against which RSM filed an appeal ("Indian Appeal"). In the Indian Appeal, the Delhi High Court directed RSM to make a request before the Appeal Court for suspension of the Dubai Court Order and to not execute the original judgment passed by the Dubai Court in UAE or any other jurisdiction until the disposal of Indian Appeal. <u>RSM filed a request before Appeal Court for suspending the precautionary attachment proceedings as directed by the Delhi High Court. The Appeal Court suspended the proceedings, and hence, the Appeal Court Order stands unenforceable. This suspension will continue till the Indian Appeal is decided by the Delhi High Court. Further, the Company has filed an appeal before the Cassation Court against the original judgment passed by the Dubai Court, and till its pendency, no execution proceedings can be initiated by RSM in UAE.</u>

	RSM and the Company further appealed the Dubai Court Order before Court of Appeals, Dubai, UAE (" Appeal Court ") which has been rejected by the Appeal Court on December 10, 2024 (" Appeal Court Order "). The Appeal Court has ordered to attach assets of the Company in UAE and has refused to cancel the trading license of Honasa Dubai Entity.
	Further, in the pending appeal proceedings in India, Hon'ble Delhi High Court (" Delhi High Court ") directed RSM to make a request before the Appeal Court for suspension of the Dubai Court Order, till the appeal is disposed. <u>RSM on December 10, 2024</u> <u>filed a request before Appeal Court for suspending</u>
	the precautionary attachment proceedings, and the Appeal Court has suspended the proceedings. Delhi High Court also directed RSM to not execute the original judgment passed by Court of First Instance, Dubai, UAE, in UAE or any other invitabilities until the annual proceedings in India
	jurisdiction until the appeal proceedings in India are disposed. For the purpose of clarity, RSM had filed an appeal against the Section 9 judgment passed by Delhi High Court wherein the Delhi High Court allowed Section 9 petition and granted anti- enforcement injunction to the Company.
