- i. The Public Advertisement with respect to dispatch of notices and conducting of voting through electronic means was published in an English newspaper "Trinity Express" and in vernacular newspaper "Makkal Kural" of vide circulation on "05.09.2024.".
- ii. The remote e-voting commenced on September 24, 2024 (Tuesday) at 09.00 A.M and ended on September 26, 2024 (Thursday) at 05.00 P.M.
- Pursuant to the Ministry of Corporate Affairs ("MCA") General Circular Nos. 14/2020, 17/2020, 20/2020, 02/2021, 19/2021, 21/2021 and 02/2022 dated April 8, 2020, April 13, 2020, May 5, 2020, January 13, 2021, December 08, 2021, December 14, 2021 and May 05, 2022 respectively, (collectively referred to as "MCA Circulars") and Circular Nos. SEBI/HO/CFD/CMD1/CIR/P/2020/79, SEBI/HO/CFD/CMD2/CIR/P/2021/1 1,SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated May 12, 2020, January 15, 2021 and May 13, 2022 respectively, issued by the Securities and Exchange Board of India (collectively referred to as "SEBI Circular"), Notice of the 31st AGM along with the Annual Report 2023-24 was sent only through electronic mode to those Members whose email addresses were registered with the Company/ Depository Participant(s).
