The notice dated 13/08/2024 along with statement setting out material facts under section 102 of the Companies Act, 2013, were sent to those members who's email address are registered with the Company/ depository participant, in compliance with the Circulars issued by the Ministry of Corporate Affairs (MCA) (hereinafter referred to as "MCA Circulars"), Government of India No. 14/2020, 17 /2020 and 20/2020 dated 8 April 2020, 13 April 2020 and 5 May 2020 read with SEBI circular dated 12 May 2020 and 15 January 2021 respectively.

2. The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and rules relating to voting through remote e-voting and voting through electronic system at the Annual General Meeting for the resolutions proposed in the notice of the 41st Annual General Meeting of the members of the Company. In accordance with the notice of the 40st- Annual General Meeting sent to the members and the advertisement published pursuant to Rule 20(4)(v) of the Companies (Management and Administration) Rules, 2014 the remote e-voting opened at 09:00 AM on Friday, 27th day of September, 2024 and remained opened up to 5:00 P.M. on Sunday, 29th day of September, 2024.

6. At the end of the voting period on Sunday, 29th day of September, 2024 at 5:00 P.M., the voting portal of the National Securities Depository Limited (NSDL) was blocked forthwith.

7. At the 41st Annual General Meeting, the facility for voting through e-voting system is available for all those members, who attended the meeting and did not cast their votes by remote e-voting and otherwise not barred from doing so.

8. The votes cast through remote e-voting and voting through e-voting system at the Annual General Meeting were unblocked on 01st October 2024 at 02:00 P.M. after the conclusion of the Annual General Meeting in the presence of two Witness Ms. Nidhi Kasture and Ms. Bharti Singh, who are not in the employment of the Company.
