Dear Sir,

The Board of Directors at their meeting held on Monday, the 20<sup>th</sup> day of May, 2024 have appointed me as the scrutinizer for scrutinizing the e-voting process in a fair and transparent manner in respect of the resolutions proposed at the ensuing Annual General Meeting (AGM) of the Company, held on 30<sup>th</sup> September, 2024 at Registered Office of the Company at 9.30 a.m.

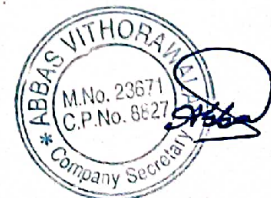
