Please note that the Company has received an Order on August 28, 2024 at 04:00 p.m., from Additional Commissioner, Customs & Central Tax, Hyderabad GST Commissionerate, Hyderabad, raising a GST demand of ₹ 98,319/-, Interest of ₹ 14,94,738/- and levying penalty of ₹ 40,000/- for FY2019-20 and GST demand of ₹ 78,81,829/-, Interest of ₹ 14,82,451/- and levying penalty of ₹ 8,07,430/- for FY2020-21 under Section 73 of the Central Goods and Services Tax Act, 2017 (“the Act”). The Company would pursue an appeal with Appellate Authorities/ evaluate other legal options against the said Order.
