SpiceJet Removed from DGCA's Enhanced Surveillance

GURUGRAM, **October 16**, **2024**: SpiceJet is pleased to announce that the Directorate General of Civil Aviation (DGCA) has removed the airline from its enhanced surveillance regime. The enhanced surveillance was initiated on 13th September 2024.
