Pursuant to provisions of Regulation 30 and 51 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended from time to time), we hereby inform you that CRISIL Ratings Limited (“CRISIL”) has reaffirmed its ratings as well as outlook and has removed from rating watch with developing implications for Bank Loan Facilities, Non- Convertible Debentures and Commercial Papers of IIFL Finance Limited (“IIFL Finance”), IIFL Home Finance Limited (“HFC”) and IIFL Samasta Finance Limited (“Samasta”), material subsidiaries of the Company.

Further, Brickwork Ratings India Pvt. Ltd (“Brickworks”) has reaffirmed its rating as well as outlook as “BWR AA+/Stable” and has removed from rating watch with negative implications for Non-Convertible Debentures of IIFL Finance.
