In compliance with SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time, and SCILAL's Policy for Determination of Materiality of Events / Information, we hereby inform that:

The Company has received email from BSE Limited dated 21.11.2024 and notice from National Stock Exchange of India Limited vide email dated 21.11.2024, levying fine of Rs. 10,22,000/- (plus 18% GST) each for non- compliance with Regulations 17(1), 17(2A), 18(1), 19 and 20 of SEBI (LODR) Regulations, 2015 w.r.t Composition of Board of Directors including failure to appoint woman director, quorum of board meetings and constitution of various statutory committees viz Audit Committee, Nomination and Remuneration Committee, and Stakeholder Relationship Committee.

The action does not have significant impact, quantifiable in monetary terms to the extent possible, on financial, operational or other activities of the Company.

It may be noted that Shipping Corporation of India Land And Assets Limited ('SCILAL'), being a Public Sector Undertaking (PSU) is coordinating with Competent Authority for appointment of requisite number of Independent Directors on its Board. Once the requisite number of Independent Directors are appointed, the Company will strive to ensure compliance with aforementioned Regulations of SEBI (LODR) Regulations, 2015.
